**PREFACE** 

Public Works Department is an integral part of the State Government by which all the works related

to the development of the State are carried out. The accounts of Public Works Divisions are

maintained as per the provisions laid down in the Jammu & Kashmir Public Works Account Code

as well as Administrative procedures and instructions issued by the State Government from time to

time.

This review on the working of Public Works Divisions for the year 2017-18 brings out

the working of the Public Works Divisions, the state of initial and subsidiary accounts kept in the

divisions, the classification and other issues noticed in the claims preferred at the treasuries.

During the financial year 2017-18, there were 281 Public Works Divisions in the Jammu

& Kashmir State (Annexure I) which carried out works of Road & Bridges, Flood & Irrigation,

Electric Maintenance & Rural Electrification, Public Health Engineering, Mechanical Engineering

and Urban Environmental Engineering of the State. The Part-I (Accounting Issues) highlights the

major areas of deficiencies in accounting procedure of Public Works and the Part-II (Financial

Management Issues) indicates the financial irregularities and mismanagement noticed during the

annual inspection of these Divisions.

From 01.04.2017, the State Government completely switched over to Civil System of

Accounts for Public Works Divisions. As such recommendations have been given in this review for

only those issues which would require follow up by the Public Works Divisions.

I hope that this Annual Review on the working of Public Works Divisions acts as an aid

to the Government to strengthen controls and to improve the functional efficiency and performance

of the Public Works Department/Divisions.

# **PART-I**

# **ACCOUNTING ISSUES**

# 1. Receipt of Monthly Accounts (Schedule portion)

Consequent upon the implementation of civil accounting system w.e.f 01.04.2017, the accounts of the Public works Divisions are being received through the concerned Treasuries in the form of vouchers/challans as in case of other civil Departments and the divisions no longer submit the compiled accounts to the office of Accountant General. However, on adoption of the civil system of accounting, the public works divisions were still required to furnish various schedules as prescribed in Para 514 of Jammu & Kashmir Public Works Account Code so as to enable this office to conduct various mandatory checks..Despite taking up the matter with the concerned Administrative Departments demi-officially vide this office No: Works-IV/2018-19/91 dated 07-06-2018 followed by reminders issued vide this office No DCW-1/Acctts/2018-19/136 dated 07-01-2019 no supporting schedules were submitted to Accountant General Office.

Statement showing Department wise details of various important Forms/Schedules awaited are given in **Annexure –II.** 

## 2. Failure of Divisional Officers to Reconcile their Accounts with Treasury.

Before switching over to the civil system of accounting, the Divisional officers were drawings moneys through cheques and making remittances into the treasuries under MH 8782., the account of which was rendered by them through compiled accounts..As per Para 497 & 499 of Jammu & Kashmir, Public Works Account Code, the Divisional Officer were required to reconcile the transactions of cheque drawn/encashed and remittance made with treasuries on monthly basis in Form 50/51, as un-reconciled balances are fraught with the risk of non detection of fictitious remittances or fraudulent drawls from the treasuries.

The divisions were required to continue with the reconciliation with the treasuries even after the shift to the civil system of accounting and render form 50/51 to this office till all the cheques drawn till 31-03-2017were actually encashed/written back or remittances in transit accounted for.

These forms from 186 divisions (**Total 2232forms**) for the year 2017-18 were awaited (Details are given in **Annexure-III**).

#### **Recommendation**

Non furnishing of Form 50-51 are a cause of great concern and requires due attention. Divisional Officers may be instructed to ensure complete reconciliation of accounts with treasuries and submit the awaited form 50/51 immediately to Accountant General office.

# 3. Unspent and Unclaimed Deposits held by the Divisions/Reconciliation of Deposits

Public Works Divisions collect deposits from contractors in the form of Earnest Money Deposit (EMD) and other Security Deposits. These deposits have to be returned to the contractors. Similarly, it also receives deposits in the form of advance payment from other agencies for carrying out public works on behalf of these agencies (Deposit Works). Unspent amounts pertaining to Deposit Works have to be returned to the concerned agencies after completion of the work and unclaimed deposits are to be credited to the Government on the expiry of specified period.

Besides, as per Para 395 and 396 read with Para 515 of Jammu & Kashmir Public Works Code, the Divisional Officers are also required to prepare a monthly schedule of Deposits in Form-78 containing therein balances held as deposit by the division for valid reasons and reconcile the figures with Accountant General's office. On implementation of civil accounting system in the public works divisions wef 1-4-2017, these balances upto 31-03-2017 were required to be got authenticated from this office after conducting the reconciliation so that these could be adopted by the treasuries. Though majority of the divisional officers conducted the reconciliation, 40 divisional officers (**Details in Annexure** 

**IV**) are yet to conduct the reconciliation, as such mismatch between Accountant General figures and divisional figures could not be ascertained.

## **Recommendation**

Divisional Officers may be directed to ensure the reconciliation of Deposits at the earliest.

#### 4. Non - Reconciliation of Accounts with the Accountant General

As per provisions of Para 18.2.1 of J & K State Budget Manual, Chapter XII, all the Controlling Officers are required to reconcile their annual expenditure and receipt transactions with Accountant General's Office as per the calendar given in Budget Manual and schedule intimated by this office annually.. This would ensure correctness of the accounts and also facilitate detection of frauds and defalcations, if any.

The re-conciliation was not done by 15 Controlling Officers as detailed in Annexure-V.

## Recommendation

Controlling Officers may be instructed to invariably conduct reconciliation of receipt and expenditure figures with Accountant General as per the scheduled dates.

#### 6. Delay in Settlement of Amounts held under Objection

Before switch over to the civil system of accounting, the Public Works Divisions were rendering compiled accounts to this office and the expenditures/payments which were not supported with stamped payee's receipt, detailed account or vouchers were kept under objection. At the time of preparation of previous year's review an amount of

Rs 1208.70 crore comprising of 22664 items were held under objection. The divisions were required to submit the requisite documents to clear these objections. As on date an amount of Rs 861.96 crores comprising of 23880 items which include clearance since previous review and addition during the current year for missing vouchers is still held under objection by AG Office for which the required documents have not been furnished by the Divisional Officers despite taking up the matter with Chief Engineers concerned.

# Recommendation

Divisional Officers may be directed to submit requisite documents to the Accountant General for clearance of these balances held under objection.

#### 7. Other Issues

I. Drawing and Disbursing officers are required to present original supporting documents viz cash memos/ firm bills/contractor bills while preferring payments at the treasuries. It was noticed that photocopies, carbon copies and duplicate contractor bills/firm bills were attached with the vouchers instead of original documents. This practice is fraught with the risk of irregular or double payment. Instances are as under:

II. The bills to the tune of Rs 8,43,333/- in the month of 03/2018 as detailed below were presented and drawn at the treasury by Executive Engineer PHE Rural Division Jammu without putting his signatures on the bills which is a serious lapse and indicate that the Government money was drawn without applying due checks as mandated upon the Drawing and Disbursing officer as per various manuals. It is also fraught with the risk of fraudulent/irregular payments.

All basic controls like signatures on bills may be invariably exercised.

Following sanction orders have been issued by Chief Engineer PW (R&B) Department Jammu in favour of various Superintending Engineers of PW (R&B) circle placed at the disposal of concerned executive Engineers during 2017-18.

The sanction orders issued were not found in order due to the following reasons.

- 1. Though the funds have been allotted for Road works, but the same have been classified under Minor Head- 001, Which is meant for Direction and Administration i.e established charges. So far as transaction relating to road works is concerned, a separate Minor head-337-Road works below Sub Major Head 03 State highways Subordinate to Major Head 5054- Capital outlay on Roads and Bridges under Demand for Grants No 16 is required to be operated. As such, the booking of expenditure by DDOs as per incorrect classification recorded in the sanctions is not in order.
- 2. As per Demand for Grants No. 16 pertaining to Public works Department, no such classification is existing therein under Major Head 5054- Capital outlay on Road and Bridges as recorded in the sanction orders.

The above sanction therefore violates the accounting principle and adversely impact the true and fair view of the accounts of the State Government.

#### **Recommendation**

Sanction orders depicting the correct classifications as per demand for grants passed by State Legislature are required to be issued to avoid the misclassification in the accounts

# **PART-II**

# FINANCIAL MANAGEMENT ISSUES

The following irregularities were noticed in the course of local Audit of Public Works Divisions ending 03/2018.

#### 1. <u>Unfruitful/Unproductive Expenditure</u>

31 Divisions incurred unfruitful/unproductive expenditure on lift Irrigation schemes, water supply schemes, construction of Road/Road links, widening of existing roads, NABARD, WSS/NRWDP/UIDSSMT, non-commissioning of receiving stations etc. amounting to Rs. **456.51 crore (ending 03/2018)** as detailed in **Annexure A.** 

#### 2. Blockade of Funds

17 Public Works Divisions did not take timely action for acquisition of land/obtaining forest clearance/unnecessary purchase of material/non-execution of work. /unrealistic estimates etc thereby blocking Rs. 229.89 crore (ending 03/2018) of Government funds incurred on different schemes as shown in Annexure B.

# 3. Irregular Expenditure

An expenditure of Rs. **70.98 crore** (ending 03/2018) was incurred by 26 divisions on unauthorized engagement of casual labour, purchases without ascertaining the reasonability of rates, un-authorized maintenance and repairs, expediting without approval of Annual Repair Distribution (ARD) Statement, hiring of private vehicles, un-authorized execution of schemes/works and defective planning in procurement of Water Meters etc. Details of the divisions and the works involved are shown in **Annexure C.** 

## 4. Unadjusted Advance Payments

Advance payments made by the Divisions to the contractor should be adjusted from the running payments due to the contractor as the work progresses. Advance payments of Rs.101.86 crore (ending 03/2018) made to the various contractors were not adjusted by 17Divisions. Details are shown in Annexure D.

### 5. Works Executed Without Administrative Approval

No work should be executed without obtaining formal administrative approval, except in case of emergency, and without first issuing technical sanction. 26 Divisions executed works valuing Rs. 628.67crore (ending 03/2018) without obtaining administrative approval from the competent financial authority and also without obtaining first technical sanction from the competent technical authority. Details of the divisions and the works involved are shown in Annexure E.

#### 6. <u>Undue Benefit to Contractors</u>

Nineteen .Public work divisions passed on an undue benefit of Rs. 33.28 crore (ending 03/2018) to contractors on the contracts under execution by them. The undue benefit was given by way of issue of cement and materials on loan basis to the contractors, less deduction of security deposit, financial aid to the contractors, payment of VAT etc. Details of the divisions and the undue benefit passed on to the contractors are shown in **Annexure F.** 

#### 7. Other Cases

It was also observed that an amount of Rs.1887.83 crore has been objected by the audit wing due to varied reasons as per details shown in Annexure G.
