OFFICE ORDER

In compliance of office of the Comptroller & Auditor General of India, New Delhi circular No. 1-Staff Wing/2014, No. 1-Staff(App-II) 63-2013 dated 06.01.2014, the following guidelines are framed for Transfer and Posting of Group 'B' & 'C' staff under the cadre control of the Principal Accountant General (General & Social Sector Audit) Madhya Pradesh, Gwalior.

- I. Transfer and Posting Boards, constituted as under, will recommend the transfer and posting of Group "B" and "C" staff.

Composition of Boards

- II. For the purpose of inter office transfer and posting of the group "B" and "C" staff under the cadre control of the Principal Accountant General (G&SSA) Madhya Pradesh, Gwalior, the Transfer and Posting Board will consist of the following members:-

- a. Senior Deputy Accountant General/Deputy Accountant General (Admn), O/o the Principal Accountant General (G&SSA) Madhya Pradesh, Gwalior.
- b. Senior Deputy Accountant General/Deputy Accountant General (Admn), O/o the Accountant General (E&RSA) Madhya Pradesh, Bhopal.
- c. Director/Deputy Director (Admn), O/o the Director General of Audit (Central Receipt) New Delhi, Branch office at Gwalior.

Seniormost officer among the above will be the Chairperson. The accepting authority regarding the recommendations of the Board will be the Principal Accountant General (G&SSA), M.P. Gwalior.

- III. For the intra office postings of Group "B" (Gazetted) staff of O/o the Principal Accountant General (General & Social Sector Audit) Madhya Pradesh, Gwalior, the Transfer and Posting Board will consist of following members:-

- a. Senior Deputy Accountant General/Deputy Accountant General (Admn)
- b. Senior Deputy Accountant General/Deputy Accountant General (General Sector)
- c. Senior Audit Officer/Audit Officer in charge of Administration Branch.

Senior most officer among the two Group Officers will be the Chairperson. The accepting authority regarding the recommendations of the Board will be the Principal Accountant General (G&SSA), M.P. Gwalior.

- IV. For the intra office postings of Group "B" (Non-Gazetted) and Group "C" staff of O/o the Principal Accountant General (General & Social Sector Audit) Madhya Pradesh, Gwalior, the Transfer and Posting Board will consist of following members:-

- a. Senior Audit Officer/Audit Officer in charge of Administration Branch.
- b. Senior Audit Officer/Audit Officer (OAD-XI)
- c. Senior Audit Officer/Audit Officer (OAD (M))

Seniormost officer among the above will be the Chairperson. The accepting authority regarding the recommendations of the Board will be the Sr. Deputy Accountant General/Deputy Accountant General (Admn).

V. The Group "B" and "C" staff shall not ordinarily be transferred from a particular group before the lapse of a minimum period of two years. Transfer of any officer before completion of the minimum period may be recommended in public interest but the reasons will be recorded by the concerned Board. The Boards would be recominendary bodies and their recommendations will be placed before the accepting authority for final orders.


