Their travel and other entitlements shall be at par with that of PAG. Besides, each honorary member shall be entitled a sitting fee of Rs.5000/- per meeting for attending the Board.

Frequency of Board meeting: At least two meetings shall be held every year, one in February/March at the time of finalizing audit plans and another in October/November when the audit reports are in the processing stage.
