## ( Terms and Conditions) for hiring Taxi/Swift Dzire new for Financial Year 2023-24:-

- 1. The rates are quoted for travelling a distance 2500 K.M. in a month.
- The cost of engaging driver, Petrol/CNG, Lubricants etc. will be borne by the bidder.
- The vehicle will normally be in use from 8:00 AM to 8:00 PM on daily basis.
