Audit Officers (Audit) in the Office of the Accountant General (Audit), Bihar on deputation on usual terms and conditions.

The desirous applicants of less than 56 years of age (as on the date of application) should submit their applications in the prescribed proforma shown in Annexure 'B' of this circular through the proper channel. The said applications should reach this office latest by or before 15.05.2021. The applications should be furnished along with a copy of APARs of last five years, Category, Inter-se-seniority list, composite statement of Cadre Clearance/ Integrity Certificate, Vigilance Clearance, Major/Minor Penalty, etc. in Annexure-'C'.
