Applications are invited for filling up the vacant posts in this office on deputation basis in various cadres on usual terms and conditions stipulated in DOPT OM No. 6/8/2009-Estt.(Pay-II) dated 17.06.2010 and amendments made thereof from time to time.

The eligibility criteria for deputation are as under:-

Sr. No.	Name of the Post & Pay Level	Eligibility
1	DEO Grade-A, Level-04	Holding the analogous post on regular basis in the parent office.
2	Clerk, Level-02	Holding the analogous post on regular basis in the parent Office.

**Terms and conditions:-**

1. The officials in the feeder cadre who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation basis. Similarly, deputationist shall not be eligible for consideration for appointment on promotion.
2. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on closing date of receipt of applications.
3. Period of deputation shall be for one year initially and can be extended further as per availability of vacancies and suitability of the candidate.

It is requested to kindly forward the applications of interested officials who fulfill the above criteria with your recommendations and along with the bio-data (Service particulars), attested copies of APARs for the last five years and vigilance clearance certificate to this office by **30.06.2023**.
