**Subject: UN Audit Examination 2020**

Sir/Madam,

An examination for shortlisting of Sr AOs/AOs/AAOs for UN Audits scheduled during 2020-21 and 2021-22 will be held in the month of **February 2020**. Officers from all streams i.e. Audit/Accounts, etc. who satisfy the eligibility criteria given in Annexure-I are eligible to apply.

2. While no restriction is placed on the number of applications to be received from an office, **it may please be ensured that names of only eligible officers are recommended**. The **entire process** i.e. filling up of application forms by the eligible officials, validation of data and recommendation of Head of the Department **is required to be done online** through the registration link to be provided in due course.

3. The examination will be held in **Computer Based Test (CBT)** mode at **seven cities** viz. Delhi, Mumbai, Chennai, Kolkata, Guwahati, Bangalore and Hyderabad, depending on the number of candidates. The syllabus and pattern of the examination is given in Annexure II.

4. The abstracts of ACRs/ APARs for the last available five years upto 2018-19 is required to be entered at the time of online registration. Certificate regarding vigilance/disciplinary clearance and penalty/administrative action such as suspension, dies-non and criminal charges clearance is also required to be given online.

5. There will be **no scope for submission of applications/documents offline** and, therefore, complete application along with all the required documents and your recommendation must be submitted **online only** when the registration window opens. If at any stage, the information furnished by any candidate(s) is found to be inaccurate, his/her candidature/selection is liable to be cancelled/terminated without any notice and action taken as per rules.

6. Officers who withdraw their candidature after being selected for UN Audit (except on severe medical grounds like surgery of self or direct family members) will be banned for a specific period from appearing/applying for international assignments/ international postings/ international training.

**Eligibility Criteria**

1. The officer should have clear 'Outstanding' APARs for at least 4 out of the last available 5 years.
2. AAOs should have a completed five years combined service in the grade of SO/AAO as on 1.1.2020. No service length is prescribed for Sr. AOs/AOs.
3. Officers who fall under any of the following categories are not eligible:
  - (a) Those who have done two or more UN Audits in the past (including those who have been selected for UN Audit during the current cycle 2019-20);
  - (b) Those who have done UN Audit during the last two cycles (including the current cycle);
  - (c) There should be a minimum gap of two years between two UN Audit assignments;
  - (d) Those who have returned from Embassy Audit are not eligible for 3 years as on 01 January 2020;
  - (e) Those who have returned from overseas posting are not eligible for five years as on 01 January 2020;
4. Officers should be clear from vigilance/disciplinary angle. Officers against whom major penalty has been imposed in the past are not eligible till five years after completion of currency of the penalty. Officers against whom minor penalty including Censure or Dies-Non has been imposed in the past, are not eligible till 3 years after completion of the currency of the punishment or the date of Censure/ Dies-Non.
5. Officers should be less than 57 years of age as on 01 January 2020;
6. Officers must possess the following attributes:
  - (a) Ability to conduct audit independently and prepare Audit Reports;
  - (b) Excellent drafting skills in English;
  - (c) Good inter-personal relationships with colleagues, superiors and subordinates; and
  - (d) Healthy and fit physically to undertake international travel and tight work schedule.

**UN Audit Examination 2020****Objective:**

The objective of the exam is to assess the suitability of officers for conducting audit of UN Organizations in the portfolio of CAG (2020 onwards).

**Required traits for suitability:**

1. **Comfort Level** in working in automated environment – Reading and analysing electronic data and document, correspondence through emails, electronic KD linking, Word Processing abilities (MS Word) and Working with spreadsheets (MS Excel).
2. **Awareness** about CAG's audit portfolio, its term and our role as external auditors of these organisations and agencies
3. **Understanding** of UN systems
  - a. Structural Organisation of UN organisations and agencies
  - b. Role of Oversight bodies like External Auditor, Internal Audit, Audit Advisory Committee, Joint Inspection Unit
  - c. Role of Legislative/Governing bodies which are charged with Governance viz General Assembly/Conference, Governing Board, Programme & Budget Committee, Audit Committee, Finance & Budget Committee in UN agencies
4. **Understanding** of Accounting and Auditing standards followed in UN viz. IPSAS, ISAs and Financial Regulations & Rules
5. **Proficiency** in Financial, Compliance, Performance and IT Audits
6. **Excellent Language and Drafting skills-** In international audits the tone of the language of observations and recommendations is very important. Command over language and use of soft words with clear meaning is essential.

**Structure of Examination:**

The examination will be held in Computer Based Test (CBT) mode. There will be a single paper of **3 hours' duration** titled “**Overview of UN System and Concepts & Skills for UN Audit**” (Paper Code: UN-1). The Paper will be of **100 marks** divided into four Sections –

The question paper will be in English language only. It will include 40 Multiple Choice Questions (MCQs) and 4 (four) to 8 (eight) descriptive type questions. There will be negative marking to the extent of 0.25 marks (25 percent) for each wrong answer for the MCQs only.

**Subject: Online registration for SAS/RA/I/CPD-I&II Main Exam 2019 –important points to be considered during online registration**

Sir/Madam,

As informed vide Examination Wing Circular No. 23 of 2019 dated 11 October 2019, the online registration for SAS/RA/I/CPD-I&II Main Exam 2019 was commenced on 15 October 2019 with the Pre-registration process, in which Part-1 of the Registration Form was filled up and submitted online by the Examination Registration Officers (EROs) of IA&AD offices.

2. The **candidates** whose particulars have been pre-filled by their respective EROs will receive their **User ID and OTP by SMS/email on 23 October 2019**. The candidates will be required to fill up Part-2 of the Registration Form, upload latest photo/scanned signature/relevant documents in Part-3, preview the filled-in form in Part-4 and submit the same. **Instructions for filling up of Registration Form is given in Annexure-I. Last date of submission of the Registration Form by the candidates is 29 October 2019.**

3. The EROs can **simultaneously** carry on the process of **verification and validation** of the Registration Form submitted by the candidates. **This process is to be completed by 31 October 2019**. Thereafter, Heads of the Department can login with his/her User ID and Password and approve/disapprove the candidature taking into consideration the relevant orders/instructions with regard to eligibility, chance, branch, exemption claimed, etc.

**Important points to be considered during the online registration process and subsequent validation of data/approval of candidature are given in Annexure II.**

4. C&AG's MSO (Admn) Vol-I and orders/circulars related to SAS/RA/I/CPD-I&II Main Examination 2019 issued by Headquarters' Office should be taken into consideration during the process of validation/approval of candidature. Once a candidate is registered, his/her chance will be treated as having availed of. Therefore, accuracy of the facts must be ensured and duplication in registration should also be avoided. **Check-list**, as shown in **Annexure III**, in this regard is required to be submitted online at the time of HoD approval.


5. Common errors/issues noticed during the registration process for earlier examinations are highlighted below for guidance of all concerned:

- ❖ Mismatch of candidate's personal details like name, father's name, category, date of birth, etc. with service records
- ❖ Incomplete/incorrect/delayed registration
- ❖ Registration of ineligible candidates
- ❖ Incorrect selection of group (Group-I / Group-II / Both)
- ❖ Non-claiming of exemption in certain papers
- ❖ Non-disclosure/ Incorrect entry of Latest Index Number

All these clearly indicate that the particulars of the candidates were not checked properly by the field offices while approving the candidature for the examination. It is, therefore, emphasised that correctness of the particulars of the candidates entered in the Registration Form should be verified from the service books and other related records in order to avoid input of wrong data.

**SAS/RA/I/CPD-I&II Main Examination 2019****IMPORTANT POINTS TO BE CONSIDERED DURING ONLINE REGISTRATION****► Fresh candidate and Repeater – definitions**

- ≡ An official will be considered a **FRESH CANDIDATE** for SAS/RA/I/CPD-I&II Exam 2019 if he/she **has not been registered earlier** (i.e. during the period from 2010 to June 2019) for the exam selected by him/her.
- ≡ An official will be considered a **REPEATER** for SAS/RA/I/CPD-I/CPD-II Exam 2019 if he/she **has been registered earlier** (i.e. during the period from 2010 to June 2019) for the exam selected by him/her.

**► Latest Index Number – mandatory for repeaters**

- ≡ NOT APPLICABLE For Fresh candidates
- ≡ **REPEATERS** must enter their **Latest Index Number** for the selected exam correctly. Non-furnishing or incorrect entry of Latest Index Number by the candidate may lead to cancellation of candidature and consequent actions as per rules.

**► Branch**

- ≡ Fresh candidates are required to **SELECT** their BRANCH according to their Cadre Controlling Authority (CCA).
- ≡ In case of Repeaters, their BRANCH will be **displayed by the system**

**► Chance**

- ≡ For Fresh candidates CHANCES AVAILABLE will be shown as “0” (ZERO)
- ≡ In case of Repeaters, CHANCES AVAILABLE will be **displayed by the system** either by number or by alphabet (e.g. A = 01, B =02.....)
- ≡ Normal number of chances for passing the SAS/RA/I/CPD-I&II Examination is six. However, candidates who have exhausted the six chances and have cleared at least five papers of SAS Examination, shall be given four additional consecutive chances.
- ≡ Candidates who have exhausted all the permissible number of chances are not allowed to appear in the SAS/RA/I/CPD-I&II Exam 2019.

**► Exemption - in exams held in CBT mode**

- ≡ NOT APPLICABLE For Fresh candidates
- ≡ In case of Repeaters, EXEMPTION (i.e. papers in which he/she secured exemption marks in examinations held in CBT mode during 2010 to June 2019) will be **displayed by the system**
- ≡ A candidate who has exhausted all the permissible number of chances shall not be eligible to claim exemption in any paper in the SAS/RA/I/CPD-I&II Main Examination 2019.

**► Cut-off date**

- ≡ The eligibility of the candidates for appearing in the SAS/RA/I/CPD-I&II Main Examination 2019 will be based on the cut-off date of 1<sup>st</sup> September 2019.



## ADDITIONAL POINTS TO BE CONSIDERED

### 1. SAS Examination

#### ► Eligibility

- ≡ Direct Recruit AAOs shall have to qualify SAS Exam in respective branches for confirmation and regular appointment as Assistant Audit Officer, during the period of probation, which is ordinarily 2 years.
- ≡ Fresh candidates (other than Direct Recruit AAOs and Adhoc Assistant Accounts Officers) who have put in minimum of 2 years of continuous service in a particular field office of IA&AD and who have successfully completed their probation period as on 1<sup>st</sup> September 2019 are eligible to appear for SAS Exam 2019. Accordingly, candidates will be required to select their present Cadre Controlling Authority (CCA) along with date of joining the CCA and the date of completion of probation.
- ≡ A candidate (Fresher/Repeater) who have joined in a particular field office of IA&AD on Mutual Transfer will be required to complete 2 years in the new office (CCA) in order to be eligible to appear in the SAS Exam. Exemption, if any, secured by a candidate in any paper earlier will be carried forward and chances availed will be counted while registering for SAS Exam 2019 from the new office on completion of the compulsory waiting period of 2 years.

#### ► BRANCH

- ≡ Fresh candidates are required to select the Branch appropriate to their Cadre controlling office e.g. candidates belonging to Commercial Audit offices should select Commercial Audit. Similarly those belonging to Railways Audit/ Defence Audit/ P&T Audit/ Civil Audit/ Local Audit/ Civil Accounts offices should select their branch accordingly. However, Hindi Translators of Rajbhasha (All India) Cadre who will register for the first time for SAS Examination are allowed to select a branch of their choice.
- ≡ Switch over of branch will require prior permission of Headquarters' Office (HQ) – granted by Commercial Audit Wing for switch over to Commercial Audit branch and by Examination Wing for switch over to any other branch. If a candidate (Fresher/Repeater) selects SWITCH OVER OF BRANCH, he/she will be required to upload HQ's letter granting such permission.
- ≡ Eligible officials of A&E offices who have exercised the option for switching over to Civil Audit branch in terms of Exam Wing Circular No. 7 of 2019 must upload the OPTION FORM submitted by them to their respective offices in terms of Exam Wing Circular No. 19 of 2019.

### ► **Chance**

- ≡ Candidates who have exhausted the six chances and have cleared at least five papers of SAS Examination, shall be given four additional consecutive chances. The four additional chances shall be counted immediately from the next SAS examination and lapse after conclusion of four consecutive SAS Examinations in which the official had the option to appear, irrespective of the fact whether he/she appears or not.

### ► **Exemption**

- ≡ Candidates claiming exemption in PC-14 / PC-15 / PC-16 paper(s) in SAS Exam 2019 on the basis of passing Non-SAS Exams ICWA, DAGE, etc. are required to **upload scanned copy of the certificate issued by the institution concerned** duly attested by the Sr. A.O. (Administration) of his/her office. For Divisional Accountants Grade Examination (DAGE) held by PAG/AG, a certificate to this effect confirming the Index Number and Year of passing is required to be obtained from the office concerned.
- ≡ A candidate claiming exemption in any paper in SAS Exam 2019 on the basis of passing SOGE/SAS Exam papers in **Pre-CBT mode** are required to **upload a certificate** from his/her office confirming his/her Pre-CBT Index Number, Year and Paper in which exemption secured.

## **2. Revenue Audit Examination (for Audit offices)**

### ► **Eligibility**

- ≡ One year of continuous service in Revenue Audit Branch as SAO/AO/AAO or after having the prescribed training in Revenue Audit
- ≡ Direct Recruit AAOs are eligible for Revenue Audit training after completion of one year of regular service after confirmation as AAO. Departmental officials promoted as AAO are eligible for Revenue Audit training after one year of continuous service

### ► **BRANCH**

- ≡ Fresh candidates are required to select their Branch according to their CCA. For Repeaters, their branch will be displayed by the system.
- ≡ Option for Section II of the paper RAE 2 Goods and Services Tax and Branch Specific Revenues will be displayed according to branch based on the revised syllabus notified vide Exam Circular No. 17 of 2019. For Commercial Audit and Civil Audit (including Local Audit and ESM&SD Audit) branches, Section IIA of RAE 2 paper will be applicable.

► **Exemption**

- ≡ Exemption in the papers of Revenue Audit Exam 2019 will be based on Exam Wing Circular Nos. 18 & 24 of 2019.

**3. Incentive Examination (for A&E offices)**

► **Eligibility**

- ≡ SAO/AO/AAOs/AAO(RT)/Sr DAO/DAO Gr-I of A&E Offices with one year of continuous service in the grade are eligible.

► **Exemption**

- ≡ Under CBT mode, PC-3 & PC-4 papers of SAS Examination are same as IE-3 & IE-4 papers of Incentive Examination. Hence, those who have secured exemption in PC-3 and PC-4 papers in CBT mode of SAS Examination are not required to appear in IE-3 & IE-4 papers.
- ≡ Officials who have passed the erstwhile SOGE/SAS Examination with “Computer Systems” paper in Pre-CBT mode are also not required to appear in IE-3 & IE-4 papers.

**4. CPD-I & CPD-II Examinations**

► **Eligibility**

- ≡ SAO/AO and Sr DAO are eligible to appear in CPD-I Exam 2019.
- ≡ AAO/AAO(RT) and DAO Gr-I who have completed four years continuous service in the grade are eligible to appear in CPD-I Exam 2019.
- ≡ CPD-II Exam 2019 can be taken after four years have elapsed from qualifying CPD-I Exam.

If more than one ERO is required, HOD of an office may send a written request to DG (Exam) by email to [dgexam@cag.gov.in](mailto:dgexam@cag.gov.in) for creation of additional Login ID.

3. The online Registration Form will be divided into four parts – **Part 1** Candidate's Profile, **Part 2** Examination Particulars, **Part 3** Upload Section (for uploading of documents, photo and signature) and **Part 4** Preview Section. Part 1 of the Registration Form is to be filled in by the office while the other Part 2 & 3 will be filled in by the candidates. Overview of the registration process is given in Annexure I. Screenshot of Registration Form Part 1 is given in Annexure II.

4. The eligibility of the candidates for appearing in the SAS/RA/I/CPD-I&II Main Examination 2019 will be based on the cut-off date of 1<sup>st</sup> September 2019. The HOD should ensure fulfillment of eligibility of a candidate for the particular examination in which he/she intends to appear.

## **Annexure I**

### **Steps involved in Online Registration for SAS/RA/II/CPD-I&II Main Examination 2019**

#### **Step 1**

This step will be called Pre-registration, in which ERO of the office concerned will login using his/her Login ID and OTP received through SMS/email and fill up Part 1 of the Registration Form to generate Login ID and OTP for each candidate. The system generated Login ID and OTP will be received by the candidates through SMS and email.

#### **Step 2**

At this step the candidate will login and check Part 1 of the Registration Form which will be pre-filled. If the candidate agrees with the data filled in by the office, he/she should proceed further to fill up Part 2 and Part 3 of the Registration Form and submit the same. Candidates may be advised to check the particulars thoroughly and upload all necessary documents/photo/signature before clicking the SUBMIT button. In case the candidate disagrees with the data pre-filled in Part 1 of the Registration Form, he/she should immediately contact the ERO of his/her office.

#### **Step 3**

After online submission by the candidates, the ERO concerned will login and verify the filled in Registration Form to check the data entered therein. In case of mismatch with service records and other relevant records, necessary correction can be made using the EDIT option. If the ERO is satisfied regarding eligibility of the candidate to appear in the examination concerned and correctness of the data entered in the Registration Form, he/she will validate the candidature using the VALIDATE option. Printout of the filled in form should be taken at this stage for office record.

#### **Step 4**

HOD of the office concerned will login at this stage using his/her Login ID and OTP received through SMS/email and give his/her approval. A check-list is required to be filled in at this stage to ensure fulfilment of the eligibility criteria of the candidates for the particular examination in which he/she intends to appear.

#### **Note:**

In case of officials on deputation, Part-I of the Registration Form can be filled in by the office in which he/she is posted if that office has been allotted an office code. However, after online submission of the form by the candidate, verification and validation of the data will be done by the ERO of his/her parent office.

In pursuance of the Supreme Court Judgment of April 1986 and the Government of India, Ministry of Personnel and Public Grievances & Pensions (Department of Personnel & Training) instructions issued vide No. 36012/23/96-Estt (Res) Vol. II dated 3<sup>rd</sup> October 2000, the Comptroller and Auditor General of India has carefully considered the extent of relaxation to be allowed to the candidates belonging to Scheduled Caste/Scheduled Tribe categories for the SAS Main Examination likely to be held in November 2019 and has decided that the extent of relaxation would be as under:-

In all papers of SAS Group – I and II there will be relaxation of upto 5 percent in each individual paper. In other words, the candidate who secure not less than 40 per cent marks in individual paper relaxation of marks upto 5 per cent in that paper will be granted to him/her to declare him/her pass as well as exempt in that paper.

The above relaxation is only in respect of SAS Main Examination 2019. The extent of such relaxation for future SAS examination for SC/ST candidates will be reviewed and notified accordingly before the commencement of such examinations.

Wide publicity may be given to this relaxation and the SC/ST candidates may be informed of the above relaxation suitably. **No hard copy of this circular will be sent.** Soft copy is available in CAG's website.

Junior Hindi Translators and Senior Hindi Translators of Rajbhasha Cadre (All India Cadre) who will register for the first time for appearing in SAS Main Examination 2019 shall be allowed to choose any branch irrespective of the office where they are serving at present. However, officials of the Rajbhasha Cadre (All India Cadre) who had earlier registered for the SAS Examination in a particular branch will be allowed to appear in that branch only unless they have obtained permission for switch over of branch from Headquarters' Office.

2. In terms of Examination Wing Circular No. 15 of 2019, permission for switch over of branch shall be granted by the Director General (Commercial) in case of switch over to Commercial Audit and in other cases by the Director General (Examination).

3. Since the Rajbhasha Cadre (All India Cadre) is maintained by the Staff Wing of Headquarters' Office, applications in the prescribed format for switch over of branches for appearing in SAS Examination 2019 in respect of the officials belonging to this cadre are required to be forwarded to the Cadre Controlling Authority i.e. Director General (Staff) for consideration and recommendation.

4. Eligible officials of some of the A&E offices who will be allowed to appear for SAS Examination 2019 in Civil Audit branch in terms of Examination Wing Circular No. 7 of 2019 are required to exercise an option in the prescribed format as per Circular No. 19 of 2019 and there is no requirement of any application for switch over in respect of such officials.

**Subject: Clarification on certain points relating to SAS Main Examination 2019**

Sir/Madam,

In terms of Para (2)(ii) of Examination Wing Circular No. 7 of 2019 dated 24/04/2019 eligible officials of some of the A&E offices, as specifically mentioned therein, will be allowed to write SAS Examination 2019 either from Civil Audit branch or from Civil Accounts branch. It has also been stipulated vide Para (2)(iii) of the said circular that option once exercised by the eligible officials may not be changed further.

2. The option shall be exercised in writing in the **enclosed format** by the eligible officials of the A&E offices concerned who intend to write SAS Examination 2019 either from Civil Audit branch or from Civil Accounts branch in terms of Para (2)(ii) of the above mentioned circular. The duly filled OPTION FORM may be retained by the offices concerned for future reference and is not required to be sent to Headquarters. These officials are not required to submit application for switch over to Civil Audit branch in terms of Examination Wing Circular No. 15 of 2019 dated 09/08/2019.

3. Officials promoted as Assistant Accounts/Audit Officer are not eligible to write the SAS Examination in any branch. However, SAS (Civil Accounts) Examination passed officials who are yet to be promoted as Assistant Accounts Officer (AAO), including Adhoc AAOs of A&E offices, may exercise the option as stated at Para 2 above for appearing in SAS (Civil Audit) Examination 2019 in terms of Para (2)(ii) of Examination Wing Circular No. 7 of 2019 dated 24/04/2019, if eligible otherwise.



4. As per Recruitment Rules to the post of AAOs, the maximum age limit for appointment by deputation shall not be exceeding 56 (fifty-six) years as on the closing date of receipt of application for deputation/absorption. Moreover, officials promoted to the post of Assistant Accounts Officer in their parent office till the date of proceeding on deputation-cum-absorption in Civil Audit Offices are not eligible to apply for absorption to the post of Assistant Audit Officer in Civil Audit Offices.

5. As provided in Para 9.2.10 of Chapter 9 of C&AG's MSO (Admn) Vol. I, the normal number of chances for passing the Subordinate Audit/Accounts Service (SAS) Examination will be six. However, the candidates who have exhausted the six chances and have cleared at least five papers of SAS Examination, shall be given four additional consecutive chances. These four additional chances shall be counted immediately from the next SAS examination and lapse after conclusion of four consecutive SAS Examinations in which the official had the option to appear, irrespective of the fact whether he/she appears or not. Therefore, the examinations in which eligible A&E officials had/have the option to write SAS (Civil Audit) Examination shall be counted against the four additional consecutive chances. On passing of the SAS Examination, the permissible number of chances that have not been availed shall lapse, except in respect of A&E officials who have the option to write SAS (Civil Audit) Examination.

6. As per Para 9.2.16 of Chapter 9 of C&AG's MSO (Admn) Vol. I, the chances already availed of by a candidate in a branch, are counted towards the maximum number of admissible chances in the other branch. Candidates who have exhausted all the permissible number of chances will not be allowed to appear as fresh candidates for any other branch of the SAS Examination.







**Subject: Switch over of branches for appearing in SAS Examination**

Sir/Madam,

As per Para 9.2.15 of Chapter 9 of C&AG's MSO (Admn) Vol. I transfers from one branch to another branch are not ordinarily permissible. In rare cases, where such transfers are found necessary in the public interest and after ascertaining that the establishment to which they seek transfer is prepared to absorb them permanently, transfers can be made with the previous sanction of the Comptroller and Auditor General of India who will lay down any further conditions necessary in each case, with due regard to the general principles governing transfers from one branch to another. The aforementioned provision of C&AG's MSO (Admn) Vol- I should be kept in view while dealing with requests for switch over of branch for appearing in SAS Examination.

*In this connection, the following general instructions are issued:*

- (i) **General Rule:** In terms of Para 9.2.14 of Chapter 9 of C&AG's MSO (Admn) Vol. I, no candidate will be allowed to appear in the Subordinate Audit/Accounts Service (SAS) Examination of any branch other than that of the branch which is appropriate to the establishment in which s/he is serving.
- (ii) **Direct Recruit AAOs:** As clarified vide Examination Wing Circular No. 10 of 2019, Direct Recruit AAOs shall have to qualify SAS Examination in respective branches for confirmation and regular appointment as AAO.
- (iii) **Departmental Candidates:** A candidate seeking switch over of branch for appearing in SAS Examination will be required to submit an APPLICATION in the enclosed format to his/her Head of the Department through proper channel.
- (iv) **NOC of HoD:** If the Head of the Department has no objection to switch over of branch in SAS Examination in respect of the official concerned, the application shall be forwarded




to Headquarters' Office for obtaining the sanction of the competent authority, as clarified in subsequent paras. Relevant provisions of Chapter 9 of C&AG's MSO (Admn) Vol. I must be considered before forwarding the application to Headquarters' Office.

- (v) **Commercial Audit Wing:** Application for switch over to Commercial Audit Branch in the SAS Examination in terms of Note 1 below Para 9.2.14 of Chapter 9 of C&AG's MSO (Admn) Vol. I shall be forwarded to the Commercial Audit Wing of Headquarters' Office for consideration. This is as per Examination Wing Circular No. 14 of 2019.
- (vi) **Examination Wing:** Application for switch over of branch in terms of Para 9.2.15 of Chapter 9 of C&AG's MSO (Admn) Vol. I shall be forwarded to the Examination Wing of Headquarters' Office for consideration. Such application must be accompanied by an ASSURANCE LETTER from the Cadre Controlling Authority to which the official is seeking transfer that on passing of the SAS Examination he/she will be permanently absorbed in that branch.
- (vii) **Permissible chances:** The chances already availed of by a candidate in a branch, are counted towards the maximum number of admissible chances in the other branch. Candidates who have exhausted all the permissible number of chances will not be allowed to appear as fresh candidates for any other branch of the SAS Examination.
- (viii) **Multiple switch overs:** Permission for switch over of branch once granted shall be final and request for reverse switch over or multiple switch overs shall not be entertained. If any such request is pending as on the date of issue of this circular, the same should be immediately brought to the notice of Examination Wing of Headquarters' Office.
- (ix) **Cut-off date:** Permission for switch over of branches in SAS Examination granted before 1<sup>st</sup> September of a year shall be effective from that year's Main Examination.
- (x) **Registration:** Particulars of all the candidates granted permission for switch over of branches must be thoroughly verified by the Field Offices at the time of registration for the SAS Examination so as to ensure fulfilment of the eligibility conditions. Particulars relating to switch over of branch will have to be entered in the registration form and, if required, scanned copy of Headquarters' letter will also have to be uploaded.

It has been decided to hold the Subordinate Audit/Accounts Service (SAS)/Revenue Audit/Incentive/Continuous Professional Development (CPD)- I and II Main Examinations 2019 in the following offices:-

**(1) SAS (Audit) Examination in Audit Offices:**

- (i) Subordinate Audit Services (SAS) Examination will be conducted (for all categories) in all the Audit Offices of IA&AD.
- (ii) Revenue Audit Examination (RAE) and Continuous Professional Development-I and II (CPD-I & II) examination will be conducted in all the Audit Offices of IA&AD.

**(2) SAS Examination in A&E Offices:**


- (i) In the A&E offices of Andhra Pradesh, Gujarat, Himachal Pradesh, Jammu & Kashmir, Jharkhand, Madhya Pradesh, Manipur, Tripura and Uttar Pradesh, officials will be allowed only to write SAS (Civil Accounts) Examination 2019 for promotion to the post of Assistant Accounts Officer in these offices.
- (ii) Eligible officials of remaining A&E offices will be allowed either to write SAS (Civil Audit) Examination 2019 for absorption to the post of Assistant Audit Officer in deficit Civil Audit Offices or to write SAS (Civil Accounts) Examination 2019 for promotion to the post of Assistant Accounts Officer.

- (iii) Option once exercised by the eligible officials of A&E offices to write either SAS (Civil Accounts) Exam or SAS (Civil Audit) Exam may not be changed further.
- (iv) As per provisions contained in Recruitment Rules to the post of Assistant Audit Officer, the maximum age limit for appointment by deputation/absorption shall not be exceeding fifty-six years as on the closing date of receipt of applications. This provision should be kept in mind while allowing eligible officials of A&E offices to write SAS (Civil Audit) Examination 2019 for absorption to the post of Assistant Audit Officer in deficit Civil Audit Offices (except A&E offices mentioned in para 2 (i) as they can write only SAS (Civil Accounts) Exam).

(3) Incentive Examinations:

Incentive Examination/Continuous Professional Development I and Continuous Professional Development II Examinations 2019 will be conducted in all A&E offices for eligible officials.

Subject: Guidelines for On-line registration of candidates for Supplementary Subordinate Audit/Accounts Service (SAS)/Revenue Audit/Incentive/Continuous Professional Development (CPD)-I Examinations of Main Examinations 2018 scheduled to be held in June, 2019 and list of Centres.

Sir/Madam,

As already communicated vide Examination Section Circular No.05 of 2019 issued vide No.287/01-Exam/Circulars/2019 dated 16-04-2019, the Supplementary SAS/RA/I/CPD-I&II Examinations of Main examinations 2018 will be held in June, 2019. The Examination would be conducted for the existing candidates i.e. the candidates who have appeared in SAS/RA/I/CPD-I&II Main Examinations of September 2018 or earlier examinations but failed to qualify the Examination. The date sheet will be issued in due course.

2. The prospective candidates for the aforesaid examinations will be registered online from 22-04-2019 to 30-04-2019. Since the registration is online, there is no scope for re-opening of the registration as well as that of entries made therein. It is therefore emphasized that the correctness of the particulars of the candidates should be verified from the Service Book and other related records. Further, once a candidate is registered the chance will be treated as having been availed of.

3. The candidates intending to appear in the above mentioned examinations are to be registered online by filling up applications in the respective Cadre Controlling offices.

- Sr. DAG/DAG (Admin) or Sr. AO/AO (Admin) of the respective offices are required to personally supervise the process of registration of the candidates and ensure correctness of the particulars of the candidates.

This will not only ensure the accuracy of the facts but also avoid duplication in registration and act as input control.



- For this purpose, the field offices should earmark one or more dedicated Personal Computers with internet facility.

The passwords for the Registration of the candidates will be sent separately. The password for the approval of candidature by the Heads of Department are being communicated separately.

### **MOST IMPORTANT**

4. Despite clear cut instructions issued to the field offices for online registration of candidates, some cases of incomplete/incorrect/delayed registration have been noticed. **There has been instance of registration of ineligible candidates.** During check of registration details it was noticed that some of the candidates at the time of registration had applied for only Group-I or only for Group-II and at the last moment requested for change of groups. Some of the candidates had not claimed exemption in certain papers at the time of registration and subsequently claimed it either after the closure of registration or at the time of issue of Admit Cards. There were also the cases where the candidates, though had registered themselves on-line in the previous examination registered again as fresh candidates by not using the Index number allotted to them in the latest examination. This was done by small alteration in the name (using space (-)/underscore (\_) or comma (,) or dot (.) or suffixing/prefixing/dropping letters in the name. **All these clearly indicate that the particulars of the candidates were not checked properly by the field offices while approving the candidature for the examination.** It should not be repeated.

In order to reduce the incidences of ineligible candidates appearing in the examination, the printout of particulars only, after submit button has been clicked, is to be taken and should be checked by the candidates and certified that particulars are correct. This should be kept on record. In case of any exigencies where this cannot be done, a list of such candidates be forwarded to this office by email to exam section mail ID [examsection@cag.gov.in](mailto:examsection@cag.gov.in).

**It may, therefore, please be ensured inter-alia that:-**

(i) Full name of the candidate and his/her parentage is recorded as per Service Book. The registration of candidates is to be approved/submitted only after complete checking of all particulars. Heads of Department are requested to please ensure that the particulars filled in are correct and complete and only eligible candidates are registered.

(ii) The particulars of the candidate are duly checked, particularly the Index No./Year/Branch in which he/she appeared, designation and the exemptions claimed. Particulars of exemptions claimed on account of SAS/SOGE/RA/I/CPD-I&II examination papers and non-SAS examination papers are filled in the appropriate fields only. The examination year in which exemption secured/earned must invariably be mentioned to enable the Hqrs. office to verify the exemption.

(iii) A field for filling up the "Unique ID Number" (UIDN) of the candidates has been created in the on-line registration form. The 'UIDN' was required to be allotted vide

Headquarter Circular No. 35-N.G.E./2005 issued vide letter No.315-N.G.E.(App)/11-2004 dated 11-05-2005. It may be ensured that the "Unique ID Number" allotted by the Cadre Controlling office is filled in at the time of registering the candidates for the Examination.

(iv) A field has been provided in the registration module for claiming exemption in PC-16 by the Divisional Accountants/DAO-II, if eligible. The year of passing the Divisional Accountant Grade Examination and the Roll No. are to be entered in the field provided therein. The particulars of the Divisional Accountants/DAO-II in regard to claim of exemption in PC-16 are to be duly checked.

(v) The candidates are to be registered by the respective Cadre Controlling offices to which they belong. Photo being uploaded is the latest one, taken not before **1st March, 2019**.

(vi) In case of transfer of any candidate to any other office after the candidate has been registered from a particular office, the fact of his transfer to other office may be reported to the Headquarters immediately. Request for change of particulars and centre may be sent only by email to the mail ID [examsection@cag.gov.in](mailto:examsection@cag.gov.in) so that appropriate action is taken early. No request for any change will be accepted after 01 June, 2018. Candidate will not be allowed to appear other than his/her place of current posting/duty station.



**Detailed instructions for Registration of Candidates for June 2019 Supplementary SAS/RA/I/CPD-I&II Examinations of Main examination 2018.**

**A- Registration of Candidates (Registration Module)**

1. Log – on to the Web address: <http://examreg.cag.gov.in/registration/>
2. System asks for your office code and password. Please enter them. Password is being sent.
3. All the important information required in the application for the registration is indicated in asterisk. The system will not allow the submission of application unless all information in the fields marked with asterisk is filled in.
4. Enter the latest CBT Index number of the candidate if he is already registered under on-line CBT mode of registration. Select Date of Birth and click submit button. Then fill the required field as asked for.
5. The candidates who have taken previous SOG examination and have not taken examination under CBT mode have to enter his/her SOGE index number, year and month in which he/she has appeared last and click on the “Submit New Registration” button. Then fill the required fields as asked for.
6. Particulars of the candidate should be checked carefully before its submission by clicking on “Submit” button. If some information is to be modified it should be done by clicking on ‘Edit’ button.

**When any of the information is modified/edited by using ‘Edit’ button, the photo with signature is to be re-uploaded by using ‘Browse’ button. Repeat, if any of the information is modified/edited by using ‘Edit’ button, photo with signature has to be re-attached/re-uploaded by using “Browse” button.**


7. Once the information is confirmed by using “confirm” button, the modification cannot be carried out at registration stage.
8. After confirmation, the system considers the application as final and generates index number of the candidate prefixing ‘S’ for SAS Examination, ‘R’ for Revenue Audit Examination, ‘I’ for Incentive Examination and ‘C’ for CPD-I and ‘CB’ for CPD-II Examinations.
9. The index number may be noted down for future correspondence and close the window.
10. To facilitate sending messages regarding generation and collection of admit cards and entry into the examination hall, it will be helpful if the optional information like e-mail address and mobile phone numbers of the candidates are filled in.
11. Each registration is counted as one attempt. w.e.f. November 2010 . There are only six attempts permissible to pass the SAS examination. However, the candidates who have exhausted all the six chances and secured exemption in/passed five papers of SAS Examination have been given **four (4) more** consecutive eligible chances commencing from

the immediate successive examination and lapsing immediately after conclusion of 4 consecutive eligible SAS examinations. Withdrawal of candidature is **NOT** permissible once the candidate is registered.

12. The centre for candidates shall be their current Duty Stations including those candidates who are on deputation to other Offices.

## **B - Approval by the Head of Department (Admin Module)**

1. HoD should thoroughly carry out all the checks as required to be exercised as per Chapter 9 of MSO (Admin) including exemption allowed.
2. Log on to the website [http://examreg.cag.gov.in/cag\\_admin](http://examreg.cag.gov.in/cag_admin)
3. System asks for your User ID and password. User ID is; 'cag', the password is being sent separately. Please enter them. HoD can change the user ID and password.
4. The Head of the Department (HoD) can see the details filled in by the candidate. The system exhibits the number of applications received till date with their Index Number.
5. Head of the Department can verify online the exemption claimed by the candidate by clicking on the registration number and the exemption matrix available on the screen.
6. HoD can modify the information furnished by the candidate through "Edit" button. After verification and modification, if any, of the details of the candidate, click on 'Submit'. This completes the HoD's approval of the application of the candidate i.e. approval of candidature of the candidate for the examination.
7. **The candidate cannot be kept under 'await' mode. His candidature has to be either 'approved' or 'disapproved'. The candidate in 'await' mode at the time of closing date will be disapproved automatically.**
8. In case of corrections of any error pointed out by the candidates regarding essential details, the same should be forwarded immediately after verification to exam section mail ID [examsection@cag.gov.in](mailto:examsection@cag.gov.in) for correction before the admit cards are generated.
9. HoD should ensure the correctness of the eligibility of the candidates and only after the verification HoD approval should accorded.






