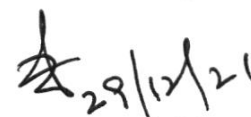

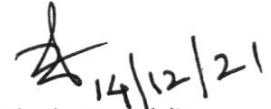
Madam/Sir,

Subject: Clarifications regarding SAS/ IE /CPD-I &II Examinations.

Based on the advice of Exam Wing, O/o Office of Accountant General, (A&E), Punjab, Chandigarh vide letter dated 30.06.2021(Copy Enclosed), requested to staff wing to clarify that:-

- i. Whether the SAS (Civil Audit) passed candidates of A&E offices who have not applied for deputation-cum-absorption basis or have not been absorbed in Audit Offices are eligible for appearing in SAS (Civil Accounts) Examination. If so, whether any declaration such as on passing of SAS (Civil Accounts) Exam, he/she will not be allowed to go to Audit office or any such undertaking is to be taken from them.
 - ii. After passing the SAS (Civil Audit) Examination, whether is mandatory for AAO (Adhoc) or SAS (Civil Accounts) passed candidates to apply for deputation-cum-absorption in the Audit offices on receipt of requisition from the Audit offices.
2. In this regard, it is stated that during the year 2012, Exam Wing vide letter dated 20.04.2012 (copy enclosed) stated that:-
- i. There are two categories of candidates in these A&E offices. One who appeared in Civil Audit branch but failed and the other, who passed Civil Audit branch but awaiting absorption in Audit office as per undertaking furnished by them.
 - ii. The Examination Section was of the opinion that so long as the candidates are on the strength of Accounts offices and have not been absorbed in audit office they can be permitted to appear in the Civil Accounts examination to be held in September 2012 because the Accounts office is their mother office.
3. The aforesaid opinion of Exam Wing was confirmed by Staff Wing Vide letter no. 436 – Staff(App I)24-2010/KW-II dated 14.05.2012 , Para (c) (copy enclosed) of which is as under:-
- “SAS Civil Audit passed candidates of A&E offices, who could not be absorbed in Audit Stream, shall have to clear the remaining papers of SAS (Civil Accounts) Examination for their promotion as Assistant Accounts Officer. However, such officials would be allowed to appear in the SAS (Civil Accounts) Examination only after furnishing a written undertaking that they agree to forfeit their claim for deputation-cum eventual absorption in any Civil Audit Office. Further, all their previous chances, which they have exhausted while appearing in the SAS (Civil Audit) examination, may be taken into account while reckoning their remaining number of chances”.
4. Therefore, SAS (Civil Audit) passed A&E officials who have not been absorbed in Civil Audit offices are eligible to appear in SAS (Civil Accounts) Exam as SAS (civil Accounts) stream is natural branch of A&E officials.
5. On passing the SAS (Civil Accounts) Exam, A&E officials are eligible for promotion to the post of Asst Accounts officer and after promotion to the post of Asst Accounts officer, the officials are not eligible for absorption in Civil Audit offices.

Subject: To allow eligible A&E officials to write SAS (Civil Audit) Examination.

Sir/Madam,

In accordance with the provisions contained in para 9.2.14 of the C&AG's Manual of Standing Orders (Administrative) Vol. - I, natural branch of A&E officials to appear in SAS Exam is SAS (Civil Accounts) Examination.

2. However, due to stagnation in A&E offices and vacancies in Civil Audit offices, eligible A&E officials are being allowed to appear in SAS (Civil Audit) Examination and on passing these officials are appointed to the post of Assistant Audit Officer in Civil Audit Offices through deputation cum absorption.

3. Now situation in A&E offices has changed and in some of the A&E offices, vacancy in the cadre of AAO is more than 20%. Therefore, by allowing A&E officials of these offices to write SAS (Civil Audit) Examination, will further aggravate vacancies in the cadre of Assistant Accounts Officer and may even lead to crippling functional situation in these A&E offices. Considering the shortage in the cadre of Assistant Accounts Officer in A&E offices, it has been decided that:

- (i) Eligible A&E officials of those A&E offices, where vacancy in the cadre of Assistant Accounts Officer is more than 20 %, as on 1st day of the month in which registration process for SAS Examination would be circulated by the Examination wing of Hqrs. office, may be allowed to write only SAS (Civil) Accounts) Examination.
- (ii) Eligible officials of remaining A&E offices where vacancy in the cadre of Assistant Accounts Officer is less than 20 %, as on 1st day of the month in which registration process for SAS Examination would be circulated by the Examination wing of Hqrs. office, may be allowed either to write SAS (Civil Audit) Examination for deputation/absorption to the post of Assistant Audit Officer in deficit Civil Audit Offices or to write SAS (Civil Accounts) Examination for promotion to the post of Assistant Accounts Officer.
- (iii) Option once exercised by the eligible officials of A&E offices to write either SAS (Civil Accounts) Examination or SAS (Civil Audit) Examination would not be changed further.
- (iv) As per provisions contained in Recruitment Rules to the post of Assistant Audit Officer, maximum age limit for appointment by deputation/absorption shall not be exceeding 56 years as on the closing date of receipt of applications. This provision should be kept in mind while allowing eligible officials of A&E offices to write SAS (Civil Audit) examination for deputation/absorption to the post of Assistant Audit Officer in Civil Audit Offices.

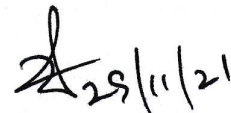

Ministry of Personnel, Public Grievances and Pensions, Department of Personnel & Training, New Delhi has issued revised guidelines for regulating advance increments granted to Stenographers of Subordinate Offices on qualifying speed test in shorthand at 100/120 w.p.m., w.e.f 01/01/2016 in the 7th CPC scenario vide OM F. No. 1/7/2017-Estt (Pay-I) dated 24/07/2020 circulated vide HQ letter No. 191-Staff Entt (Rules)/A.R/03-2021 dated 31/08/2021.

2. The speed test for Stenographers may be conducted locally at respective field offices as per their requirement once in a year in the month of September in accordance with the provisions contained in the OM ibid. The question paper may be set locally by an officer not below the rank of DAG/Dy. Director. The advance increments may be sanctioned by the Heads of Department from the date of passing the test. 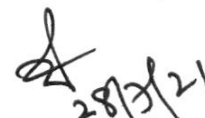

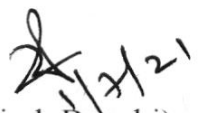

The registration process for the SAS/RA/I/CPD-I, II & III Examinations in Examination-1of 2021 will commence from 7th June 2021. The dates and schedule of the examination will be intimated in due course.

A Group Officer may be nominated as Examination Registration Officer (ERO) to manage the registration process. The basic data i.e. Name, DoB, Category etc as mentioned in Service Books of the fresh candidates may be entered into the first part of the Registration Form by the ERO. Thereafter, the fresh candidates will complete second part of the Registration form by themselves. The existing candidates will fill up the second part of the Registration Form directly. The ERO will verify and validate the data entered into the online registration forms to enable the HoD to approve their candidature. ***The onus of correctness of data is completely on the field offices.*** The registration process including HoD approval may be completed as soon as possible. The candidates may keep in view that system of withdrawal of candidature after registration has been dispensed with.

The field offices who could not complete the mandatory pre examination training to become fresh candidates eligible for the Exam may complete the training on MS Team/offline as soon as possible. However, only in ***extreme*** situation, field offices may complete the mandatory pre examination training before declaration of the Exam result. The mandatory pre examination training completion certificate will invariably be provided to Exam Wing failing which candidature of such candidates will be invalid.

The officials who are on deputation to other offices within the department may submit their willingness/applications directly to their parent offices under intimation to Administration of the borrowing offices. Such candidates will make all examination related communications with their parent offices directly for timely completion of registration process/other examination related issues.

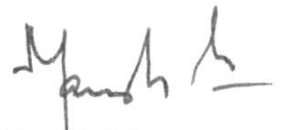
Madam/Sir,

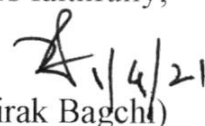

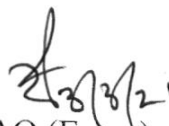
