### Part-II of SOGE (Commercial)

All the papers as per the revised syllabus of January 2007.

B. Part-II passed candidates of SOGE Civil Accounts, Civil Audit, Railway Audit & P&T Audit shall have to clear following additional papers:

### Part-I of SOGE- Commercial

- i) Government Auditing (for Civil Accounts Branch only),
- ii) Principles of Management and Indian Macro Economic Environment,
- iii) Commercial Laws and Corporate Tax.

### Part-II of SOGE- Commercial

All papers except common papers passed earlier.

C. The switch over candidates requiring to qualify additional papers of SOGE Part-I- Commercial and modified paper on CPWA, shall be required to secure at least 40 per

cent marks in these additional papers for exemption from further appearance therein. Marks secured in these papers shall not be taken into account for determining the aggregate marks of Part-I of SOGE (Commercial). The examination will also be held for all the Section Officers (Probationers) and all such candidates of A&E offices who desire to appear in SOGE (Civil Audit).

The ensuing Section Officers' Grade Examination, Revenue Audit Examination for SOs/AAOs in Audit offices and Incentive Examination for SOs/AAOs in A&E offices is proposed to be held from 20<sup>th</sup> November 2007 to 7<sup>th</sup> December 2007 (excluding holidays), as detailed in Annexure 'A'.

The Practical examination of the 'Computer Systems' paper in SOG Examination and 'Data Processing and Computer Systems' paper in Incentive Examination for SOs/AAOs in A&E offices will be conducted in 03 (three) batches each day. ### INSTRUCTIONS FOR PREPARATION OF LIST OF CANDIDATES.

### INTRODUCTION

1. With the declaration of results and communication of marks of failed candidates of Section Officers Grade Examination held in December 2006/January 2007, updated consolidated list showing the names and other particulars of all the eligible candidates who have applied and been permitted to take the examination to be held in November/December 2007 is required to be furnished by all the field offices in the prescribed form. The consolidated lists of candidates should be furnished to this office as early as possible but not later than 31<sup>st</sup>July 2007. This information is also essential to assess the number of copies of the relevant question papers required to be got printed.

### **GUIDELINES**

- 2. For the purpose of processing the finalisation of the entire results of the Section Officers Grade Examination on computer, it is imperative that field offices prepare and furnish the list of candidates with <u>utmost care and accuracy</u>. In this connection, some of the guidelines which have been issued from time to time are reiterated below:
- (i) In the lists of candidates of Part-I, the names of failed candidates who have already been allotted Permanent Index Number will appear first strictly in ascending order of their index numbers

The names of candidates who are appearing for the first time as also those candidates who have come on transfer from other offices will appear next and the column meant for indicating index number will be left blank. The Index Number for them will be given by this office and intimated to you in due course. In case of transferees, their old Index Numbers must, however, be given in the remarks column for cancellation of their old number. Likewise names of such candidates should also be given in the prescribed proforma (in duplicate) for allotment of new Index Numbers.

(ii) The names of those candidates who are to take one subject of Part-I alongwith Part-II as a result of their securing exemptions in the remaining subjects in earlier examinations will appear next. Their name and number will be the same as for Part-I given by Headquarters earlier with <u>FIRST LEFT HAND SIDE DIGIT "1" BEING REPLACED BY "2".</u> The names of such candidates should be included in both Part-I and Part-II list of candidates. Necessary note to this effect may also be made in remarks column. The names of such candidates who have already been allotted Index Number of Part-II and have to appear in one subject of Part-I, will be shown at the end of list, indicating their permanent Index Number of Part-II already allotted to them.

### PART-II

(iii) The list of candidates should be prepared in ascending order of Index Number only. In case of candidates who have passed Part-I and have not been allotted Part-II Index Number, the Index Number will be changed by replacing 1<sup>st</sup> digit of "1" as "2" and will be placed in proper place in ascending order alongwith old candidates.

The name of such candidates, who have neither been allotted permanent Index Number in Part-I nor in Part-II in the SOG Examinations and now intend to take Part-I

or II, will appear at the end of respective lists and the column meant for indicating Index Number, must be left blank for allotment of fresh Index Number. The names of candidates of Part-II who have come on transfer from other offices will also appear at the end of the list for allotment of fresh Index Number, their old Index number being indicated in the remarks column.

Essentially the list of candidates for Part-I as well as Part-II should be prepared in such a way that the Index Numbers are invariably indicated in ascending order.

### DIRECTLY RECRUITED SECTION OFFICERS

Directly recruited Section Officers who have appeared in the Section Officer Grade Examination held in December 2006/January 2007 and failed will reappear in the relevant Part of Section Officers Grade Examination along with other regular candidates of respective branches. Similarly, directly recruited Section Officers who have to appear for the first time in SOGE will appear alongwith other regular candidates. The directly recruited Section Officers who appeared in the Section Officers Grade Examination held in a December 2006/January 2007 and have passed Part-I will take Part-II of the Section Officers Grade Examination of the relevant branch subject to completion of their prescribed course of training at R T I. The Heads of Departments in whose offices these candidates have been allotted will send separate lists, in prescribed proforma for Part-I and Part-II together with their relevant particulars. The Heads of Departments in whose offices directly recruited Section Officers have been allotted will clearly indicate in consultation with the Principal of the respective RTI/RTCs, the centre of examination of these candidates in the remarks column of the consolidated lists.

### A&E CANDIDATES APPEARING IN SOGE (CIVIL AUDIT)

A distinct list of candidates from A&E office appearing in SOGE (Civil Audit) may be furnished.

### A&E CANDIDATES APPEARING IN (COMMERCIAL AUDIT)

A distinct list of candidates from A&E Offices appearing in SOGE (Commercial Audit) may be furnished.

### OTHER ATTRIBUTES OF CANDIDATES

- (4) Apart from above, the following information may also invariably be included in the list.
- (a) Number of chances already availed of in Part-I with Index Number and month/year of each appearance.
- (b) Exemption marks secured in subject /subjects, where there are theory and practical papers of a subject, marks to be shown separately.

- (c) <u>Fitness certificate vide para 9.2.11 of MSO (A) Vol.I duly signed by the Heads of Departments</u>. This certificate may be recorded after strict compliance of the provisions of this para.
- (d) Training completion certificate wherever prescribed in respect of SOG Part-I, SOG Part-II, RAE and IE alongwith the list of candidates (including directly recruited Section Officers on probation ) and Training completion certificate in respect of the paper of 'Computer System' in SOGE and "Data Processing and Computer Systems' paper in I.E may also be furnished.
- (e) In the statement of candidates for Part-II, information regarding the month/year of Part-I Examination in which the candidate has passed together with Index Number allotted in that year's Examination should also be indicated in relevant column of the statement.
- (f) If a candidate belongs to SC/ST community, the names of such candidates in Bold Capital Words, the total numbers of such candidates in Part-I as well as Part-II in the forwarding letters may also be indicated.
- (g) <u>Information relating to candidates appearing first time in Section Officers Grade</u>

  <u>Examination who have qualified in the Preliminary Test should be indicated in remarks column.</u>

### **CONDUCT OF EXAMINATION**

(5.) Information regarding the number of halls arranged for the purpose and the number of candidates who would be appearing in different parts and branches of the Examination in the different halls may kindly be furnished to this office by the respective heads of offices who have been nominated as "Officer in charge" for conducting the Examination at the various centres sufficiently in advance but not later than 31st July 2007 positively, by FAX/SPEED POST. This will enable us to send the required number of question paper/packets to each centre.

The instructions issued vide Sh. Mathrani's D.O. letter Number 658 Exam/11790 dated 9.10.1990 may also be strictly kept in view while preparing the list of candidates.
