Principal Accountant General (Audit),TG is the Cadre Controlling Authority for the Offices of The Principal Accountant General (Audit),TG and Director General of Audit (Central), Hyderabad.

Direct Recruitment for the two Offices in respect of Assistant Audit Officers, Clerical Cadre (Viz., Auditors, Clerks, Hindi Typists, Stenographers, Data Entry Operators and Multi-Tasking Staff) is made through the Staff Selection Commission.

**GUIDE TO UNIQUE ID NUMBER (New Personal Number)**

A unique ID Number to each Group 'A'(NON-IA&AS), Group 'B' and 'C' including MTS (Erstwhile Group D) employee of IA&AD is allotted and shown in the Gradation list as on 01-03-2006 onwards as per Headquarters' Office instructions replacing the ID Number (Old Personal Number). The new Unique ID number consists of total 12 characters (05 alpha characters and 07 numeric characters) and is allotted to the employees in the following manner:

1. FIRST TWO CHARACTERS (ALPHA) FROM THE LEFT WILL INDICATE THE CODE FOR THE NAME OF THE STATE WHERE THE EMPLOYEE IS CURRENTLY POSTED.
2. THIRD AND FOURTH CHARACTERS (ALPHA) FROM THE LEFT WILL INDICATE THE CODE FOR NAME OF THE STATION WHERE THE EMPLOYEE IS POSTED
3. FIFTH CHARACTER (ALPHA) WILL INDICATE THE CODE FOR THE TYPE OF THE OFFICE i.e. CIVIL AUDIT/ A&E/ P&T/ RAILWAY ETC.
4. THE NEXT THREE CHARACTERS (NUMERIC) WILL INDICATE THE CODE OF THE CADRE CONTROLLING OFFICE.

In case of Posting of the employees in Small Offices /Resident Audit Offices (RAOs) located at different places in the same State, the station code relating to the Head Office would be allotted.

**Note: 1.** The last seven characters (Numeric), once allotted by the Cadre Controlling Office, will remain unchanged throughout the service of the employees except in the case of Mutual /Unilateral transfers in which case on account of change of the Cadre Controlling Office, new ID number would be allotted to the employee concerned by the new Cadre Controlling Authority.

**2.** In case of transfer of employees from one office to another office on deputation basis within IA & AD, the first five (05) ALPHA characters are changeable according to the present posting of the employee. Hence, if the Officer, Sri X is transferred on deputation to the office of Principal Accountant General (Audit), Kerala, Thiruvananthapuram then the ID number would be KLTVA 3011201 and if the same Officer is transferred on deputation to the Office of the Principal. Accountant General(Civil &Commercial Audit), Karnataka, Bangalore, the ID number would be KABNB 3011201.
