ORDER

Subject:- Revised rates of Dearness Relief to Haryana Government pensioners and family pensioners w.e.f. 1st July, 2021.

The Governor of Haryana is pleased to decide that the Dearness Relief payable to Haryana Government pensioners and family pensioners shall be enhanced from the existing rate of 17% to 28% of the basic pension with effect from 1st July, 2021.

2. The increase subsumes the additional instalments arising on 01.01.2020, 01.07.2020 and 01.01.2021. The rate of Dearness Relief for the period from 01.01.2020 till 30.06.2021 shall remain at 17%. The payment on account of Dearness Relief involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored. All other conditions for payment of Dearness Relief to Pensioners & Family Pensioners on revised Pension & Family Pension contained in FD's instructions No.2/23/2016-1 pension dated 3rd March, 2017 shall be applicable.

3. This is in continuation of Finance Department's earlier instructions No.4/1/2009-5FR(FD)/8101 dated 6th July, 2020, vide which instalments of Dearness Relief to Haryana Government pensioners and family pensioners due from 01.01.2020, 01.07.2020 and 01.01.2021, were frozen.

Subject: Disbursement of one month salary in lieu of LTC for Government employees.

In pursuance of Government of Haryana Finance Department order No. 4/12/2020- 2 FR/8664 dated 04.06.2021 vide which it has been decided to release LTC for certain categories of Haryana Government Employees and Pensioners mentioned below on first come first serve basis: -

- i) Pensioners who have attained the age of 70 yrs and more.
- ii) Employees who are going to retire in 2021, are allowed LTC in the month of their retirement.
- iii) Employees retired in the year 2020, who have applied for LTC and not availed yet.
- iv) LTC to the employees of three Departments namely Health, Medical Education and Police Department, subject to the condition that release of LTC will be within the budget of current year 2021-22.
- v) LTC to the employees of other Departments and remaining Pensioners may be released in the next two years 2022 and 2023 of current LTC block year.
