

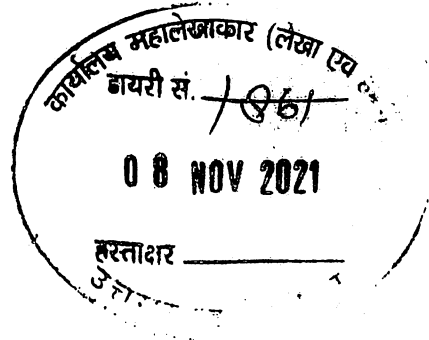

The Government of Haryana is pleased to decide that the Dearness Allowance payable to Haryana Government Employees, who are drawing their pay as per 6th Pay Structure, shall be enhanced from the existing rate of 164% to 189% of the pre-revised basic pay with effect from 1st July 2021.

1. The increase subsumes the additional instalments arising on 01.01.2020, 01.07.2020 and 01.01.2021. The rate of Dearness Allowance for the period from 01.01.2020 till 30.06.2021 shall remain at 164%. The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored. The provisions contained in para 3,4,5 & 6 in FD's instructions No. 4/3/2016-5FR/35222 dated 25th November, 2016 shall continue to be applicable while regulating Dearness Allowance under these instructions.


