

So Kindly take this issue seriously and explain some reasonable question as a case study and ensure accountability, transparency and good governance through high quality auditing and accounting and provide independent assurance to our ultimately stakeholder the innocent and the poor Public, that public funds are being used efficiently and for the intended purposes.

- 2. He is appointed as chemist in pay scale 5000-8000 in 1988, who is competent authority for appointment as chemist? what is the source of appointment? Is

chemist post is created under work charge establishment? Is he is covered under resolution No 6394 dated 23.10.87 of Finance Department, Bihar which stated that work charge employees who completed his service 5 years as work charge employee on 21.10.1984 is eligible for regularized his service in regular work charge establishment?

3. His Service is regularized in 2006 but he got increment and other facility since 1981 and got salary 70K in 2016 which should be audited properly.


