Subject: - Subordinate Audit/Accounts Service (SAS)/Revenue Audit (RA)/Incentive (I)/Continuous Professional Development (CPD- I, II & III) Examination-II of 2022.

HQ office, vide letter no. 628/13-Exam/Examination-I /2022 dated 24/11/2022 (Copy enclosed) has intimated that Examination-II of SAS/RA/CPD 2022 will be held from 15/12/2022 to 20/12/2022.

HQ office, vide letter no. 627/13-Exam/Examination-I /2022 dated 24/11/2022 has fixed the cut off as 01/11/2022 for checking the eligibility of candidates. The candidates who successfully completed their probation period and who have completed 2 years of continuous services on or before 01/11/2022 shall be allowed to appear in the SAS II Examination of 2022.

Vide Circular No.11 of 2020 dated 19/10/2020, the number of chances to pass SAS Examination have been increased from 10 to 12. Additional six chances may be admissible only to those candidates who have cleared five papers within first (normal) six attempts (6+6=12). Six additional chances will not be consecutive as earlier but the time limit for passing the SAS Examination will be eight years considering two examinations in a year (8 years for 12 chances) w.e.f. SAS Examination-I of 2021. Those who have already exhausted ten chances will be allowed two chances irrespective of any time limit from SAS Examination-I of 2021 and has to avail these two chances within two years i.e. four Examinations (counting from Examination-I of 2021).

Vide Circular No.03 of 2021 dated 13/04/2021, Headquarter has permitted to avail two additional chances in four examinations w.e.f. Examination –I of 2021 during two years i.e. 2021 & 2022 as a one-time opportunity to existing candidates of RA/I/CPD-I&II Examinations who have exhausted all permissible six chances but could not clear the Examination.

Eligibility Criteria for appearing in RAE:- (i) Sr.AOs after having one year of continuous service in the Revenue Audit Branch as AAO/Sr.AO or after having prescribed training in the Revenue Audit are eligible to appear in RAE Examination [Para 9.3.1.1 of CAG's MSO (Admn.), Vol. I].

(ii) Departmental officials who are promoted as AAO are eligible to appear in RAE after completion of one year of continuous service in Revenue Audit Branch; or have the prescribed training in Revenue Audit after completion of one year of continuous service as AAO.

(iii) Confirmed directly recruited AAOs are eligible to appear in RAE after completion of one year of regular service in Revenue Audit Branch as a regular AAO; or have the prescribed training in Revenue Audit after completion of one year of regular service after confirmation as AAO.

Eligibility Criteria for appearing in CPD:- All Sr AOs shall be eligible to take the first CPD test. AAOs including AAOs (Regular Temporary) shall be eligible to appear in the first CPD test after completion of four years continuous service in the grade. The second CPD test can be taken

by Sr. AO/AAO after elapse of four years from qualifying their first CPD test (CPD-I). The third and final CPD test can be taken by the Sr. AO/AAO after elapse of three years from qualifying their second CPD test (CPD-II).

As such, eligible candidates who intend to appear in the SAS/RAE/CPD-I, II & III Examination-II of 2022 may submit their application in the prescribed proforma (attached or download from office website) by **25.11.2022 strictly**. Incomplete applications or applications received after the specified date shall not be entertained. **The candidates who have applied earlier for the Examination-2 of 2022 need not to apply afresh.**

The intending candidates for the aforesaid examinations may please note carefully that each registration is counted as one attempt. Thus, only candidates who are prepared to take the examination should register for the examination. Withdrawal of candidature is not permissible, once the candidate is registered.

The intending candidates working on deputation in other offices should send their applications through their present employer.


