CIRCULAR

Please find enclosed a copy of the email dated 06.02.2023 issued by the Training Division of the Headquarters office. All eligible SAOs/AAOs of this office who intend to appear in the CPD Examinations of 2023 (Examination 1 and Examination 2 of 2023) are requested to furnish their willingness, to appear in the said CPD Examinations specifically stating the stage of examination for which they are eligible and the name of paper/s for which training (ONLINE) is required. The stated willingness statement should be forwarded to the Confidential Cell invariably **on or before 09.02.2023** clearly mentioning contact number (active mobile number) along with active official email id, **under intimation to the respective Controlling Officers. Further before furnishing the willingness statement, the following points as envisaged in the HQrs afore stated email dated 06.02.2023, should invariably be taken into account.**

- The pre-examination training is **optional**.
- The CPD pre-examination training will be conducted **only once** in a year for both the Examinations i.e. Examination 1 and 2 of respective year.
- The pre-examination training for CPD examination is to be provided **only once** for each stage of CPD examination i.e. once for CPD I examination, once for CPD II Examination and once for CPD III Examination.
- The officers, who have **attended** the pre-examination CPD training conducted online in the Year 2022, should not apply for this training.
- SAOs/ AAOs who are eligible as on **1st March 2023** for Examination 1 of 2023 and who are eligible as on **1st September 2023** for Examination 2 of 2023 is **only to be considered for the said training.**



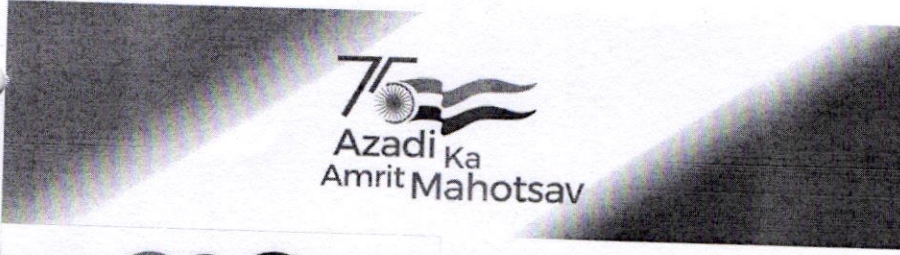
