On subject cited above, with reference to your letter no. SAI-Pen1/Ex-MLA/25-26/30722 dated 16.06.25, I have been instructed to write to you that necessary instructions should be issued immediately to all District Treasury Officers regarding the pension admissible to the Spouses of Ex-MLAs that the basic pension of the family pensioners of all Ex-MLAs of Punjab is not eligible for an increase of 5, 10 and 15 percent after they attain the age of 65, 75 and 80 years respectively.

ABSTRACT

Pongal Festival, 2025 - Grant of Pongal Prize to 'C' and 'D' Group Pensioners / All Family Pensioners - Sanctioned - Orders - Issued.

Read the following:-

G.O.Ms.No.1, Finance (Allowances) Department, dated: 02-01-2025.

-*****-

ORDER:

The Government sanction a lumpsum Pongal Prize amount of Rs.500/- (Rupees Five Hundred only) to Government Pensioners who retired from the categories of 'C' and 'D' Group as annexed to this order including 'C' and 'D' Group of Pensioners of Aided Educational Institutions, Local Bodies, Ex-Village Establishment, Ad-hoc Pensioners of all categories (those who are drawing Special Pension of Rs.2,000/- with effect from 1-10-2017 i.e. Noon Meal Organisers, Anganwadi Workers, Mini Anganwadi Workers, Cooks, Cook Assistants, Anganwadi Helpers, Panchayat Secretaries, Village Librarian, Sweepers/ Sanitary Workers/ Scavengers, Plot Watchers, Anti-poaching Watchers, Police Station Cleaners, Ayah and to all Family Pensioners irrespective of the Groups from which the Pensioners / Government employee had retired/ died while in service.

2. This order shall also be applicable to all 'C' and 'D' Group provisional pensioners. The Pongal Prize amount shall not be admissible to those employees who retire on or after 02-01-2025.

3. Those who have retired/died in harness on or after 01.10.2023 are not eligible for the Pongal Prize amount if they are paid Adhoc Bonus as per the orders issued in the Government Order read above. For this purpose, the Pension Disbursing Officers shall obtain non-drawal certificates from the departments concerned before making payment to these Pensioners.

4. This order is not applicable to the following categories of pensioners:-

(i) Special Pensioners such as Ulema Pensioners, State Freedom Fighters Pensioners and Social Pension for Scholars and Eminent persons, etc.

(ii) Family Pensioners who are appointed on compassionate grounds if adhoc bonus/special adhoc bonus is paid to them as applicable to the employees in service.

(iii) All Pensioners who retired from Group 'A' and 'B' posts including All India Service Officers and Officers governed by University Grants Commission (UGC) / All India Council for Technical Education (AICTE) / Indian Council of Agricultural Research (ICAR) Regulations.

5. The Government also direct that the procedure indicated below shall be followed for disbursement of Pongal Prize amount in respect of Pensioners/Family Pensioners coming under the Pension Pilot Scheme.

- (i) In respect of those Pensioners /Family Pensioners to whom pension/family pension is sent by Money Order at Government cost, the Pongal prize amount also shall be sent by Money Order at the Government cost.
- (ii) In respect of Pensioners/Family Pensioners to whom pension/family pension is paid through Banks,
 - (a) In Pension Pay Office, Chennai and District Treasuries/ Sub-Treasuries where the cheque system of payment of bills/Electronic Clearing System is in vogue, the Pension Pay Officer, Chennai and District Treasury Officers/Sub Treasury Officers are permitted to issue cheques and send the cheques to the respective paying branches of the bank with a covering list of Pensioners/Family Pensioners for crediting the amount to the Pensioners'/Family Pensioners' savings bank account.
 - (b) As regards Banking Sub-Treasuries where the cheque system of payment of bills/Electronic Clearing System is not in vogue, the Sub-Treasury Officers are permitted to get Banker's cheque/Bank draft and send them to the respective Pensioners for crediting the amount to the Pensioners'/Family Pensioners' savings bank account.

6. In respect of Pensioners /Family Pensioners for whom expenditure is met from State Consolidated Fund, the expenditure shall be debited to the following Head of Account:-

"2071 Pensions and Other Retirement Benefits - 01 Civil -
800 Other Expenditure - State's Expenditure - AF Pongal
Prize to Pensioners and Family Pensioners - 327 Pensions-
09 Others.

IFHRMS: (D.P.C. 2071 01 800 AF 32709)"

In respect of payment of Pongal Prize to Ex-Village Officers, the expenditure shall be debited to the following Head of Account:-

"2071 Pensions and Other Retirement Benefits - 01 Civil -
800 Other Expenditure - State's Expenditure - AK Other
Expenditure - Pongal Prize to Ex-Village Officers -
327 Pensions - 09 Others.

IFHRMS: (D.P.C. 2071 01 800 AK 32709)"

7. In respect of 'C' and 'D' Group Pensioners /Family Pensioners of Local Bodies for whom expenditure is met from the fund maintained by the Directorate of Local Fund Audit or Municipal Funds, as the case may be, the expenditure shall be met from the respective funds. In respect of Special Pensioners of Noon Meal Organisers, Anganwadi Workers, Mini Anganwadi Workers, Cooks, Cook Assistants and Anganwadi Helpers, the Block Development Officers / Child Development Project Officer concerned shall debit the expenditure under the head of account mentioned in para-6 above.

8. The Pongal Prize amount sanctioned above shall be paid to the eligible Pensioners/Family Pensioners and Ex-Village Officers immediately.

9. Necessary provisions has been made under the relevant head of account in Budget Estimate 2024-2025.





Preamble:

General Administration Department vide Resolution dated 02.11.2022 at Read (2), instructions were issued regarding the restoration of the commuted value of pension after a period of 13 years for officers of the All India Services, Gujarat Cadre, who were drawing their pension from the Treasury Office of the State of Gujarat. Subsequently, requests were received from retired AIS officers drawing pensions from other State/outside Gujarat State Treasury Offices for the extension of the benefits of the said Resolution to them. The matter of extending the benefits to these officers was under active consideration of the Government. After due consideration, the Government hereby resolves as follows:

Resolution:

The conditions stipulated in paragraphs 3(2), 3(3), and 3(4) of the aforementioned Resolution at Read (2) are hereby deleted. And it is further resolved that Resolution dated 02.11.2022 will be applicable to Such AIS officers:

- (1) Who received their initial payment from Gujarat and subsequently transferred their pension to another State or the Central Pension Accounting Office (CPAO).
- (2) Whose pension was sanctioned by the Government of Gujarat and who received their initial payment from another State or the Central Pension Accounting Office (CPAO).
- (3) Who belonged to the Gujarat Cadre but were on deputation to the Central Government, and retired from the Central Government itself, and whose pension was sanctioned by the Central Government and the initial payment was received from the CPAO/another State.

2. AIS officers whose 15-year period for the commuted portion of pension payment was completed prior to the General Administration Department Resolution dated 02.11.2022 shall not be eligible for this benefit.

3. AIS officers whose 13-year period for the commuted portion of pension payment is completed on or after the date of this General Administration Department Resolution dated 02.11.2022 will be paid the arrears as lump sum in September-2025 (for a maximum of 24 months). The remaining arrears out of the 24 months from September 2025, if any, will be payable in subsequent instalments on 15th January and 15th July.

4. AIS officers whose 13-year period for the commuted portion of payment is due on or after September 2025, will be paid the arrears of the commuted portion of pension for the applicable month within the 15-year completion period (a maximum of 24 months) in subsequent instalments on 15th January and 15th July each year.

5. For granting the benefit of restoration of pension after 13 years to the officers of the All India Services, the concerned Department (General Administration Dept./Home Dept./Forest Dept.) shall forward the proposal received in the prescribed format (Annexure -A) along with the undertaking of the concerned pensioner (Annexure-B) to the O/o Directorate of Pension and Provident Fund, Gandhinagar.

6. Based on the consolidated information provided by the General Administration Department/Home Department/Forest Department, the O/o Directorate of Pension and Provident Fund, Gandhinagar shall issue the authority regarding the difference in Commuted Value of Pension, and thereafter the O/o Directorate of Pension and Provident Fund, Gandhinagar shall prepare the Bill in a Simple Receipt and present it to the Treasury Office, Gandhinagar, for its payment.

7. The concerned pensioner shall be informed about the payment of the arrears of the restored commuted portion of pension.

8. At the time of revision of pension, the restoration shall be done in stages after 13 years from the date of commutation for each payment made under the CVP revision in as many stages as the revision has occurred. The maximum payment shall be for 24 months.

9. The expenditure on account of the commuted portion of pension is to be met from the following budget head:

10. The liability for income tax payable on the arrears of the restored commuted portion of pension shall rest with the concerned Pensioners.

The State Government had sanctioned 53% (in Seventh Pay Scale) and 246% (in Sixth Pay Scale) dearness relief w.e.f. 01.03.2025 on pension/family pension to their pensioners/family pensioners vide Finance Department Memo No. 310/F 2013-04-00416/Fin./Rule/IV, dated 14.05.2025

2. The State Government has now decided that the dearness relief admissible to pensioners should be sanctioned as given below. The additional pension payable to old pensioners shall also qualify for dearness relief.


3. The above dearness relief shall be payable to the persons receiving pension, family pension and extra ordinary pension under the restrictions contained in the Chhattisgarh Government, Finance Department's Memo No. 677/279/2024/ Fin./Rule/IV, dated 23-09-2024 (Finance Circular 07/2024 Encl.) and Finance Department's Memo No. F.B.6/43/76/R-II/IV, dated 5-10-76.

4. Pensioners, who have commuted a part of their pension, shall be paid the dearness relief on their original pension (pension before commutation).

5. Fraction of rupees of the amount to be paid as dearness relief shall be rounded off to the next rupee.

6. All Treasury Officers/Sub Treasury Officers/Pension Disbursing Officers are directed to make payment of the above sanctioned dearness relief to State Government Pensioners early, keeping in view the amended provisions of S.R.347 of the C.G.T.C. Volume-1, issued vide Finance Department's endorsement No.E-4/1/83/R-V/IV, dated 29th January, 1983. After payment of dearness relief the same may be got checked from the usual payment authority received from the Accountant General, Chhattisgarh. If some inaccuracy/discrepancy comes to the notice, the same may be adjusted in the payment on next month.



GOVERNMENT ORDER NO. FD 18 SRP 2025,
BANGALORE, DATED 15th OCTOBER 2025.

Government are pleased to enhance the rates of Dearness Allowance payable to the State Government Employees in the 2024 Revised State Pay Scales from the existing 12.25% to 14.25% of the Basic Pay with effect from 1st July 2025.

2. For the purpose of this order, the term 'Basic Pay' means, pay drawn by a Government Employee in the scale of pay applicable to the post held by him and includes:

- a. Stagnation increment, if any, granted to him above the maximum of the scale of pay in 2024 Revised Pay Scales;
- b. Personal Pay, if any, granted to him under sub-rule (3) of Rule 7 read with Rule 3(c) of the Karnataka Civil Services (Revised Pay) Rules, 2024;
- c. Additional increment, if any, granted to him above the maximum of the scale of pay.

3. For the purpose of grant of dearness allowance the basic pay shall not include any emoluments other than those specified above.

4. Government are also pleased to enhance the rates of Dearness Allowance to the State Government Pensioners/Family Pensioners as well as to the Pensioners/Family Pensioners of the Aided Educational Institutions whose

Pension/ Family Pension is paid out of the Consolidated Fund of the State from the existing **12.25% to 14.25%** of the Basic Pension/Family Pension with effect from **1st July 2025**.

5. For the purpose of grant of dearness allowance the basic pension/family pension shall not include any other emoluments not specified in Rule 3 of KCS(RP) Rules, 2024 and orders issued thereunder.

6. These orders are also applicable to the retired employees of the UGC/AICTE/ICAR scales of pay.

7. These orders will apply to the full time Government Employees, Employees of Zilla Panchayats, Work Charged Employees on regular time scales of pay, full time Employees of the Aided Educational Institutions and Universities on regular time scales of pay.

8. Separate orders will be issued in respect of Employees on UGC/AICTE/ICAR scales of pay and in respect of Judicial Officers on NJPC Pay Scale.

9. The increase in Dearness Allowance admissible under this order is payable in cash until further orders.

10. The payment on account of revision of dearness allowance involving fractions of 50 paise and above shall be rounded off to the next rupee and fractions less than 50 paise shall be ignored.

11. The arrears of dearness allowance admissible under this order shall not be payable before the date of disbursement of salary for the month of October 2025.

12. The dearness allowance will be shown as a distinct element of remuneration and shall not be treated as pay for any purpose.




