Subject : General transfer of Divisional Accounts Officers and Divisional Accountants
for the year 2021.

Sir/Madam,

Your case may come up for transfer during the process of general transfer of Divisional Accounts Officers and Divisional Accountants for the year 2021.

2. You are advised to indicate your request, if any for the posting by location (not by divisions) out of the list of places likely to be vacant in the enclosed Annexure 'A'. Your request may be made in Annexure Performa (Annexure 'B') indicating also the special circumstance if any, for your request.
3. It may please be noted that request for preference of place does not entitle you to any particular posting. Transfer/postings will be decided by following proper procedure and subject to administrative exigencies and availability of division as per entitlement at choice station. Please note that your previous posting in any particular region will also be a factor in determining your new place of posting. In view of this, please take your earlier posting in view, while indicating your preference.
4. Classification of divisions has been made on the basis of new guidelines in respect of Transfers and postings of Divisional Accounts Officers/Divisional Accountants issued by Headquarters office vide letter dated 20/03/2015 & 06/01/2016. Thus Sr.DAO are entitled for Very Heavy divisions, DAO-I are entitled for Heavy divisions, DAO-II for Medium divisions and Divisional Accountants for Light divisions. Your preference of station may be made strictly according to your entitlement of divisions. The option/preference exercised for a station where no division as per entitlement is vacant/likely to be vacant shall be considered as having made no option. In such cases, the transfers/postings will be made as per administrative convenience only.
5. It may also be noted that where a single choice of station is preferred this shall be treated as that the official has no other preference and in such cases if no division of his entitlement is available at his choice station he/she would be considered for posting elsewhere.

6. Your request may be sent so as to reach Ms. Veenus Chaudhary, Sr. Dy. Accountant General (A&E), Office of the Pr. Accountant General (A&E), Gujarat, Ahmedabad. 380009 by 17/6/2021 preferably by Registered Post. In case of non receipt of request, it will be presumed that you have no request.
