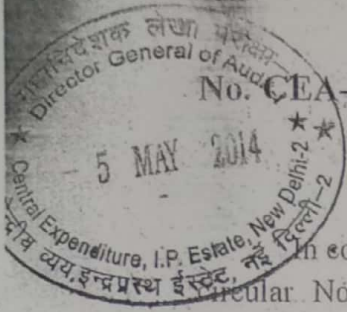

OFFICE ORDER

2. For the intra office posting of Group "B" (Non-Gazetted) and Group "C" staff (posted in Gwalior & Raipur unit) of O/o the Director General of Audit (Central receipt) New Delhi, Branch- Gwalior, the Transfer and Posting Board will consist of following members:-

- Branch Officer in charge of Administration Branch.
(i.e. in-charge of GE Section)
- Branch Officer (in-charge of ITA)
- Branch Officer (in-charge of CRA-I)

Senior most officer among the above will be the Chairperson. The accepting authority regarding the recommendations of the Board will be the Group officer (Central) in charge of Admin.




2. Transfer and Posting of Group 'B' (non-Gazetted) and Group 'C' within the office.




