The online registration for SAS/RA/I/CPD-I, II & III Examinations in Examination – 1 of 2024 will commence from 20<sup>th</sup> November, 2024 and will end on 30<sup>th</sup> November, 2024. The intending and eligible candidates (both fresh and all existing) may submit their completed applications (in the enclosed format) by 25<sup>th</sup> November, 2024 (Monday) to the Confidential Cell after due verification with Service Book. Incomplete applications and applications received after the last date will not be entertained. The chance of a candidate would be counted once she/he registers and there is no scope for withdrawal. The cut-off date for eligibility for the examination is 1<sup>st</sup> September, 2024.

The officials who are on deputation to other offices within the department may submit their applications directly to this office under intimation to Administration of the borrowing office. Accordingly, the officials who are on deputation in this office may also follow the same procedure for examination application purpose.

The Examination is scheduled from 17/12/2024 to 23/12/2024. Examination Date Sheet will be circulated as and when received from Headquarters office. All intending and eligible candidates are requested to visit the examination circular module available in the CAG website to acquaint them with the registration process.
