As per Headquarters Examination Wing circulars dated 19.11.2025 and 19.12.2025, the next proposed SAS/I/CPD-I, II & III Examination-II of 2025 will be held from 28th January 2026 to 1st February 2026 as per date sheet enclosed in Annexure-1. Applications are invited from eligible candidates willing to appear in this Examination in the prescribed format for registration of the said examination latest by 29.12.2025.

मुख्यालय के परीक्षा विंग के दिनांक 19.11.2025 के परिपत्र के अनुसार, अगली प्रस्तावित SAS/I/CPD-I, II & III Examination-II of 2025, परीक्षा परिशिष्ट-1 में दर्शाए दिनांक शीट के अनुसार 28 जनवरी 2026 से 1 फरवरी 2026 तक आयोजित की जाएगी। अतः, इस परीक्षा में सम्मिलित होने के इच्छुक पात्र उम्मीदवारों से परीक्षा के लिए रजिस्ट्रेशन करने हेतु विहित प्रारूप में दिनांक 29/12/2025 तक आवेदन आमंत्रित किए जाते हैं।

The eligibility criteria for appearing in SAS/I/CPD-I, II & III Examination-II of 2025 is mentioned below:

वर्ष 2025 की एसएस/आई/सीपीडी-आई, II और III परीक्षा-II में उपस्थित होने के लिए पात्रता मानदंड नीचे दिए गए हैं:

SAS Examination:

SAS Examination-II of 2025 will be conducted in new revised syllabus.

एसएस परीक्षा-II, 2025, नए संशोधित पाठ्यक्रम के अनुसार आयोजित की जाएगी।

Only existing department candidates are allowed to appear in SAS Exam-II of 2025.

एसएस परीक्षा-II 2025 में केवल विभाग के मौजूदा उम्मीदवार ही उपस्थित होने की अनुमति हैं।

The new paper added i.e PC-12, PC-13, PC-14, PC-15 and PC-16 have to be attempted by all the candidates of respective streams.

नए जोड़े गए प्रश्नपत्र हैं PC-12, PC-13, PC-14, PC-15 और PC-16 , जिन्हें संबंधित शाखा (Respective Streams) के सभी उम्मीदवारों द्वारा देना अनिवार्य है।

All eligible candidates have to appear in the respective papers as per exemption matrix.

सभी पात्र उम्मीदवारों को छूट मैट्रिक्स के अनुसार संबंधित प्रश्नपत्रों में उपस्थित होना अनिवार्य है ।

The details of syllabus, objectives, reference books for every paper and paper-wise exemption matrix have been uploaded on CAG's official website. Also, the sample model questions have been uploaded on CAG's official website under departmental examination tab.

प्रत्येक प्रश्नपत्र के लिए पाठ्यक्रम, उद्देश्य, संदर्भ पुस्तकें और प्रश्नपत्रवार छूट मैट्रिक्स का विवरण सीएजी की आधिकारिक वेबसाइट पर अपलोड कर दिया गया है। साथ ही, नमूना मॉडल प्रश्न भी सीएजी की आधिकारिक वेबसाइट पर विभागीय परीक्षा टैब के अंतर्गत अपलोड किए गए हैं।

Incentive Examination:

Divisional Accounts Officer Grade-I who have put in one-year continuous service in the grade as on 01.09.2025 and all Sr. DAOs who did not appear in this examination or could not clear the said examination while working as DAO-I are also eligible to appear/reappear in this examination.

वे विभागीय लेखा अधिकारी ग्रेड-I, जिन्होंने 01.09.2025 को इस ग्रेड में एक वर्ष की निरंतर सेवा पूरी कर ली है, तथा वे सभी वरिष्ठ लेखा अधिकारी, जो इस परीक्षा में शामिल नहीं हुए थे या विभागीय लेखा अधिकारी श्रेणी-ii के रूप में कार्य करते हुए उक्त परीक्षा उत्तीर्ण नहीं कर सके थे, वे भी इस परीक्षा में शामिल होने/पुनः शामिल होने के पात्र हैं।

CPD-I:

All Sr. DAOs are eligible to appear in the CPD-I Examination-II of 2025, DAO-I would be eligible to appear in the examination only after completion of four years of continuous service as on 01.09.2025.

सभी वरिष्ठ विभागीय लेखा अधिकारी सीपीडी-आई परीक्षा-II वर्ष 2025 में उपस्थित होने के लिए पात्र हैं। सभी विभागीय लेखा अधिकारी श्रेणी-1, जो 01.09.2025 को चार वर्ष की निरंतर सेवा सफलतापूर्वक पूरी कर ली है वे 2025 की CPD-I परीक्षा-II के लिए पात्र हैं ।

CPD-II:

All those candidates who have successfully completed 4 years of regular service as on 01.09.2025 after passing the CPD-I Examination are eligible for CPD-II Exam-II of 2025.

वे सभी उम्मीदवार जिन्होंने सीपीडी-I परीक्षा उत्तीर्ण करने के बाद 01.09.2025 तक नियमित सेवा के 4 वर्ष सफलतापूर्वक पूरे कर लिए हैं, वे वर्ष 2025 की सीपीडी-II परीक्षा-II के लिए पात्र हैं।

CPD-III:

All those candidates who have successfully completed 3 years of regular service as on 01.09.2025 after passing the CPD-II Examination are eligible for CPD-III Exam-II of 2025.

वे सभी उम्मीदवार जिन्होंने सीपीडी-II परीक्षा उत्तीर्ण करने के बाद 01.09.2025 तक नियमित सेवा के 3 वर्ष सफलतापूर्वक पूरे कर लिए हैं, वे 2025 की सीपीडी-III परीक्षा-II के लिए पात्र हैं।

Such of the eligible candidates who intend to appear in the SAS/I/CPS-I, II & III Examination-II of 2025 may submit their duly filled in applications in the prescribed proforma (Enclosed) and mail the same to wm1.mh2.ae@nic.in by 29.12.2025. Registration period for candidates eligible for appearing in the examination will be from 22-12-2025 to 02-01-2026. No application will be accepted after due date.
