If it appears to the Appointing Authority, at any time, during or at the end of the period of probation that a Government servant has not made sufficient use of his opportunities or in not making satisfactory progress, the Appointing Authority may revert him to the post held substantively by him immediately preceding his appointment, provided he holds a lien thereon or in other cases may discharge or terminate him from service. A probationer reverted or discharged from service during or at end of the period of probation shall not be entitled to any compensation.

The venue for above said examination is proposed to be conducted in Annexe Building Multi-Purpose Hall of this office and Index Number allotted to the intending candidate will be communicated to them in due course.
