Subject: -Revision of Rate of Dearness Relief to State Govt. Pensioners/family pensioners w.e.f. 01-01-2023.

In pursuance to the Govt. of India, Ministry of Personnel, Public Grievances & Pensions OM No.42/04//2023-P&PW(D) dated: 6th April'2023 (copy enclosed) on the subject mentioned above, the Governor of Arunachal Pradesh is pleased to order that the Dearness Relief (DR) payable to State Government Pensioners/Family Pensioners shall be enhanced by 4% from the existing rate 38% to 42% of the basic pension with effect from 1st January'2023. The DR arrears for the period from 1st January'2023 to 30thApril'2023 shall be paid in cash.

All other terms and conditions as enunciated in the Govt. of India, Ministry of Personnel, Public Grievances & Pensions' OM No.42/07/2022-P&PW(D) Dated 8th October'2022. shall remain unchanged.
