Subject: Modified rates of Dearness Relief in respect of the West Bengal Government Pensioners/family pensioners payable from 01.04.2008 to 31.12.2015

In continuation to this office Circular No. Pen.Co-ordn./93 Vol VI/20 dated 14.05.2026, regarding the modified rates of Dearness Relief payable from January, 2016 to December, 2019, it is stated that the Government of West Bengal has decided, vide their Notification No. 1909-F(P2) dated 29.05.2026 to further release of arrear of dearness relief to the State Government Pensioners/Family Pensioners for the period from April 2008 to December 2015.

Accordingly, all disbursing authorities of other states including Pr. AsG/AsG offices are requested to make necessary arrangements for payment of arrears of Dearness Relief through the pension disbursing authorities under their control for the period from 01.04.2008 to 31.12.2015 to the West Bengal Government Pensioners/Family Pensioners at the following modified rates, applicable on basic pension or family pension as the case may be under ROPA 2009, as decided by the Government and communicated under letter Nos. FS-96/2026 dated 07/04/2026, followed by FS-101/2026 dated 04/05/2026.

In this connection, it is to state that in certain cases the cumulative net arrear calculation may result in a negative balance, leaving no margin for adjustment against positive arrear balances of subsequent periods. This matter has been referred to the State Government seeking specific operational guidelines. Pending receipt of clarification/further communication from this office, **no recovery shall be effected** in such cases, and the **net** payable arrear shall be treated as **Zero**.
