Subject: Grant of Dearness Relief to the. pensioners/family pensioners of West Bengal Government @ 14% drawing pension at revised rate consequent on implementation of WBS (ROPA), 2019 and @ 161% to the pensioners/ family pensioners drawing pension at the pre-revised rate *i.e.* as per WBS (ROPA) 2009, both w.e.f. 1/4/2024 instead of 1/5/2024.

In continuation to this office circulars No. Pen. Co-ordn/93 Vol. VI/212 dated 18/3/2024, it is stated that the Govt. of West Bengal, Finance (Audit) Department, in their Memo no. 2691-F (P₂) dated 11/6/2024 (copy enclosed), have decided that the rate of Dearness Relief as was allowed vide their Finance Department Memo. No. 1090-F (P2) dated 1/3/2024 shall be effective w.e.f. 1/4/2024 instead of 1/5/2024.

No changes of the other provisions laid down in their memo. dated 1/3/2024 has been intimated by the government.

All Pension Disbursing Officers are, therefore, requested to make necessary arrangements for payment of dearness relief at the rates as mentioned in the subject above from 1/4/2024 instead of 1/5/2024 to all eligible pensioners/family pensioners of State Government.

In this context, it is also to state that no separate circular will be issued with regard to grant of dearness relief on pension/family pension to the teaching and non-teaching pensioner/family pensioners of Non-Govt. Educational Institution and Non Govt. Colleges for this time.

Accountants General of other States are requested to arrange extra copies of the said Govt. order at their end, if necessary, for circulation within their State.
