**ORDER:**

In the reference 9<sup>th</sup> read above, Government have released Five (5) Dearness Relief (DR) installments due from 01.07.2019 to 01.07.2021, to the pensioners of Government of Andhra Pradesh who are drawing pay in RPS-2015 and RPS-2022 and have also released the same to those who are drawing their pay in the revised UGC Pay Scales-2016 upto 01.07.2021.

2. In respect of the pensioners / family pensioners those who are drawing their pay in the revised UGC Pay Scales-2006 & the Judicial Pensioners / family pensioners, whose pay scales were revised as per Shri Padmanabhan Committee Report, vide G.O.Ms.No.73, Law (LA&J SC-F) Department dated 01.05.2010, the Dearness Relief (DR) installments were released only from 01.07.2019 to 31.12.2021.

3. In the reference 10<sup>th</sup> read above, Government, have already issued orders for revision

of the Dearness Allowance (DA) to the employees those who are drawing their pay in the revised UGC Pay Scales-2006 and to the Judicial Officers, whose pay were revised as per Shri Padmanabhan Committee Report from 189% of the basic pay to 196% of basic pay with effect from 1<sup>st</sup> July, 2021.

4. In the reference 11<sup>th</sup> read above, the AP Retired College Teachers' Association have requested to implement enhanced DR from 1<sup>st</sup> July, 2021 by 7% from 189% to 196% as per the Memorandum issued by the Government of India as per OM No 1/3(1)/2008-E.II (B), dated 01.11.2021.

5. Government, after careful consideration, hereby orders for the revision of the Dearness Relief (DR) to the pensioners/family pensioners, those who are drawing pension in revised UGC Pay Scales-2006 from 189% of the basic pension to 196% of basic pension with effect from 1<sup>st</sup> July, 2021.

6. Government also hereby order that the revision of rates of Dearness Relief mentioned at para 5 above are also applicable to the Judicial Pensioners / family pensioners, whose pension were revised as per Shri Padmanabhan Committee Report, vide G.O.Ms.No.73, Law(LA&J SC-F) Department, dated 01-05-2010 from 189% of the basic pension to 196% of basic pension with effect from 1<sup>st</sup> July, 2021.

7. The Dearness Relief proposed to sanction in the paras 5 & 6 above shall be paid in cash with Pension of April, 2022 onwards. The arrears on account of payment of Dearness Relief for the period from 1<sup>st</sup> July,2021 to 31<sup>st</sup> March 2022, shall be paid in cash in 3 equal installments along with the monthly pension of June, September & December 2022.

8. All the Treasury Officers/Pension Payment Officers shall ensure that the bills are supported by proper schedules in duplicate indicating the details of pensioner/family pensioner in terms of orders issued in G.O.Ms.No.122, Finance (Pen.I) Department, Dt: 22.05.2014.

9. The expenditure is allocable among the various States in accordance with provisions of Rule 24 of the incidence of pension rules in Appendix III-B of the Andhra Pradesh Accounts Code, Volume-I.

10. In respect of the Pensioners of the Universities, the expenditure on account of the Dearness Relief now sanctioned above shall be met from the Block Grants allotted to them.
