READ:-

Government Resolution, Finance Department No. NVT/102010/D/66/P (Pension Cell) dated 24.09.2022 in respect of Commuted Portion of Pension after the period of 13 years.

PREAMBLE:-

In pursuance of State Government's decision in respect of restoration of Commuted portion of Pension after the period of 13 years, the Finance Department vide its Resolution dated 24.09.2022, referred to at above has issued the instructions for restoration of Commuted Pension after the period of 13 years for the employees of the State Government.

In view of the above, the matter regarding grant of benefit of restoration of commuted portion of pension after 13 years to the All India Services officers/Retired All India Services officers was under active consideration of the Government.

RESOLUTION:-

The applicability of the provisions of aforesaid Resolutions of the Finance Department to the members of All India Services / Retired All Indian Services Officers has been considered in light of the All India Services (Death-Cum-Retirement Benefits) Rules, 1958, the All India Services (Commutation of Pensions) Regulations, 1959 & other related provisions.

After careful consideration, the Government is pleased to resolve that the members of All India Services (IAS/IPS/IFS) who will retire after implementation of this Resolution as well as All India Services Pensioners be granted the benefit of restoration of Commuted portion of Pension after 13 years from the respective dates of Commutation of Pension.

2. As the pension of All India Services officers is reimburse from the Consolidated fund of India, it is resolved that the expenditure of balanced period i.e. two years (fourteenth and fifteenth year) will be borne by the State Government and be met from the following budget Head :-



3. It is further resolved that the provision of this Resolution will not be applicable to (1) the member of All India Services who has not availed the option of Commutation of Pension (2) the member of All India Services

central deputation and receiving pension thereafter and (4) the member of All India Services who has opted for receiving pension from State/Central Government but receives pension from any other treasury outside the State of Gujarat.

4. These orders will be effective from the date of issuance of this Government Resolution. However, in respect of the cases where the period of commutation of portion of pension is more than 13 years, the restoration of commuted portion of pension would take effect from the next month of issuance of this Government Resolution.
