The period of deputation will be initially for a period of one year, which may be extended up to three years, subject to his/her being found suitable to hold the post.

Eligibility:

a) (I) Holding the analogous post on a regular basis.

OR

(II) Three years of service in the grade rendered after appointment thereto on regular basis in Level 6 of Pay Matrix (Pay scale of Sr. Auditor) / combined regular service of three years in the grade of Senior Auditors and Assistant Supervisors.

AND

b) Possessing three years of experience in the field of Welfare or Community activities, Housekeeping, Sports and Cultural Activities, Personnel Administration including settlement of Personal claims etc.

The period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or other organisation/department of the Central Govt. shall ordinarily not exceed three years. **The maximum age limit for appointment by deputation shall be not exceeding 56 years as on 19.04.2024.**

Applications must include full details of qualifications, experience, etc. and must reach OE/Administration (Audit-I), through Administration wing of the concerned office, on or before **19.04.2024**.
