Sub:-Filling up of vacant posts of Assistant Audit Officers in the Office of Principal Director of Audit, Railway, Mumbai at Mumbai (Branch Office) on deputation basis.

Applications are hereby invited for appointment to the following post on deputation basis in this office on the terms and conditions laid down in Headquarters letter No. 60- Staff(App) – I/14-2023 dated 27/01/2025 as well as other guidelines issued in this regard from time to time.

2. The eligibility criteria for appointment to the said post are as under:

Name of the post	Eligibility
Assistant Audit Officer	(i) Officers under the Cadre Controlling Authority in the Indian Audit and Accounts Department holding analogous posts of Assistant Audit officer or Assistant Accounts officer in pay Matrix -8 as per 7th CPC (alongwith officers who have been granted NFU) or who has passed the Subordinate Audit Service or Subordinate Accounts Service Examination under other Cadre Controlling Authority in the Indian Audit and Accounts Department. (ii) Directly recruited officials shall apply for deputation only after successful completion of probation period and after completing 5 (five) years of service.

3. The initial period of deputation will be for one year and may be extended thereafter, subject to suitability and administrative convenience.
4. The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date of receipt of applications.
5. Deputationists will be eligible for Railway Pass and PTO and Railway residential accommodation as per entitlements.
6. The officials opting for deputation will be posted at the Branch Office located at Mumbai/Ahmedabad/any other division under its jurisdiction.
7. While sending the applications, the provisions of the deputation policy of Headquarters dated 27/01/2025, may be strictly complied.
8. In this regard, it is requested to kindly recommend the names of eligible officials who are willing and can be spared immediately in the event of their selection to the respective posts on deputation basis.
