During probation it is required to quality the Divisional Accountant Grade Examination.

The marks obtained by them in the previous examinations itself indicates that they are not sincere towards qualifying the Divisional Accountant Grade Examination which further shows that they are not inclined to continue in service.

If it appears to the Appointing Authority at any time, during or at the end of the period of probation that a Govt. Servant has not made sufficient use of his opportunities or is not making satisfactory progress, the Appointing Authority may discharge or terminate him from service.

Competent Authority has considered your request to extend probation period and allowed to appear in the next Divisional Accountant Grade Examination to be held in September – 2022.

They are advised in their own interest to make their full efforts for clearing the said exam in next attempt as it would be upon the Competent Authority to allow or not for further extention in probation period and additional chance for appearing in the said examination.
