The basic information to be checked are as follows:

- 1. Name should match in both PIMS and service book.
- 2. Date of birth should match in both PIMS and service book.
- 3. Date of entry into Government service should match in both PIMS and service book.
- 4. Date of retirement should match in both PIMS and service book.
- 5. The ID mark of a government servant should match in descriptive roll and service book.
- Name and date of birth as recorded in the <u>Aadhaar</u> card may be furnished in both service book and list of family members (Inclusion of grandchildren in the family list may be avoided).

This is being done to avoid sending of objections/observations at a later stage. Therefore, all stakeholders are requested to kindly cooperate for betterment of the system.
