The undersigned is directed to refer to this Department's OM No. 42/02/2024-P&PW(D) dated 30.10.2024 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government Pensioners/Family Pensioners, shall be enhanced from the existing rate of 53% to 55% of the basic pension/family pension (including additional pension/family pension) w.e.f 01st January, 2025

2 These rates of DR will be applicable to the following categories -

(i) Civilian Central Government Pensioners/Family Pensioners including Central Govi absorbee pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D)Vol II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years

(ii) The Armed Forces Pensioners/Family Pensioners and Civilian Pensioners/Family Pensioners paid out of the Defence Service Estimates

(iii) Ai india Service Pensioners/Family Pensioners

(IV) Railway Pensioners/Family Pensioners

5 In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately

6 It will be the responsionly of the pension disbursing automates, including the nationalized banks etc. to calculate the quantum of DR payable in each individual case

7 The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of Dearness Relief to Pensioners/Family Pensioners on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of etter No 528 TA, II/34-80-1 dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No 2958/GA-64 (ii) (CGL)/81 dated the 21st May 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks
