No. 1/3(2)/2008-E.II(B) dated 12<sup>th</sup> June, 2023 on the subject mentioned above and to say that the rate of Dearness Allowance (DA) in respect of employees of Central Government and Central Autonomous Bodies, who are continuing to draw their pay in the pre-revised pay scale as per 5<sup>th</sup> Central Pay Commission shall be enhanced from the existing rate of 412% to 427% of Basic Pay w.e.f. 01.07.2023

2 The provisions contained in paras 3, 4 and 5 of this Ministry's O.M. No 1(13)/97-E.II(B) dated 3<sup>rd</sup> October, 1997 shall continue to be applied while regulating Dearness Allowance under these orders.


