PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Subject: - Grant of Interim Relief to the State Government employees.

READ: G.O.No. FD 45 SRP 2022 dated 19.11.2022.

PREAMBLE:

In G.O. dated: 19-11-2022 read above orders have been issued constituting the 7th State Pay Commission to examine the demands of the State Government employees. In view of the demands of the State Government employees pending receipt of the report of the 7th State Pay Commission, the State Government as a matter of policy have decided to grant interim relief to the State Government employees, employees of the Local Bodies and Aided Educational Institutions and also to the non-teaching staff of the Universities.

Accordingly, the following orders are issued.

GOVERNMENT ORDER NO. FD 07 SRP 2023

BANGALORE, DATED: 1st MARCH 2023

Government are pleased to sanction Interim Relief at the rate of 17% of the Basic Pay of the State Government employees drawing pay in 2018 Revised Pay Scales with effect from 01.04.2023.

2. Basic Pay for the purpose of Interim Relief means, the pay drawn by a Government employee in the scale of pay applicable to the post held by him and includes:

- a. Stagnation increment, if any, granted to him above the maximum of the scale of pay.
- b. Personal Pay, if any, granted to him under sub-rule (3) of Rule 7 read with Rule 3(c) of the Karnataka Civil Services (Revised Pay) Rules, 2018.
- c. Additional increment, if any, granted to him above the maximum of the scale of pay.

3. Basic Pay shall not include any emoluments other than those specified above.

4. Government are also pleased to sanction Interim Relief at the rate of 17% of the Basic Pension/Family Pension with effect from 1st April 2023 to the State Government Pensioners/Family Pensioners as well as Pensioners/Family Pensioners of the Aided Educational Institutions whose Pension/Family Pension is paid out of the Consolidated Fund of the State.

5. These orders are applicable to the full time employees of the Local Bodies and Aided Educational Institutions and employees of Universities on regular time scale of pay.

6. The Additional Expenditure on account of grant of this benefit to the employees of Local Bodies (Urban Local Bodies and Universities) shall be borne by the respective Local Bodies.

7. These orders are not applicable to employees on UGC/ICAR/AICTE/NJPC scales of pay and NJPC pensioners.

8. The payment of amount on account of Interim Relief involving fractions of 50 paise and above shall be rounded off to the next rupee and fractions less than 50 paise shall be ignored.

9. The amount of Interim Relief sanctioned in this Order is **sui generis** and shall not count as emolument for the purpose of pensionary benefits/dearness allowance or any other purpose.

10. The expenditure on Interim Relief shall be borne under the same head of account from which the pay is being drawn.
