The Government of West Bengal, Judicial Department under their letter No. I/568404/2024-J/JD/VI/2A-14/17 dated 22/10/2024 has communicated that the rate of dearness relief on basic pension/family pension for the retired Judicial Officers of Govt. of West Bengal and family pensioners of such category has been enhanced from 50% to 53% with effect from 01/07/2024.

Accordingly, in continuation to this office circular No. Pen. Co-ordn./65 Vol.V/05 dated 05/04/2024, all concerned Pension Disbursing Authorities are requested to make necessary arrangement for payment of Dearness Relief @ 53% to the above category of pensioners / family pensioners with effect from 01/07/2024 where pension/family pension has been revised as per instruction of this office circular issued vide No. Pen. Co-ordn./65 Vol. V/94 dated 27/09/2023 read with Pen. Co-ordn./65 Vol. VI/96 dated 20/09/2024, after proper adjustments of payment already made.

Payment of Dearness relief involving a fraction of a rupee shall be rounded off to the next higher rupee.


