

Subject:- Grant of Ex-gratia payment to the pensioners/family pensioners of Non-Govt. Colleges for the year 2022-2023

The Govt. of West Bengal, Department of Higher Education, Budget Branch in their Memo No. 12-Edn(B)/1M-12/2008 dated 20/04/2023 have sanctioned payment of ex-gratia grant of Rs.2900/- (Rupees two thousand nine hundred) only in lump per head to all teaching/non-teaching pensioners / family pensioners of State Aided Colleges including the holders of provisional pension who retired prior to 30.09.2022 and also the pensioners who retired or died after 30.09.2022 but prior to 01.09.2023 and are not eligible to receive ad-hoc bonus.

- 2. The benefit will be admissible only to the pensioners/family pensioners whose basic pension/family pension along with dearness relief as on 31st March 2023 did not exceed Rs.33000/-(Rupees thirty three thousand)only. The benefit is not admissible to those who are entitled to ad-hoc bonus sanctioned by the Government and those who are employed / remployed under any Public Undertaking / Statutory Bodies / Non-Government Educational Institutions and are in receipt of bonus or ex-gratia payment in lieu thereof during the current financial year.
- 3. All concerned Pension Disbursing Officers are, therefore, requested to allow ex-gratia grant @ Rs.2900/- (Rupees Two thousand nine hundred) only in lump per head.
- 4. The payment of ex-gratia as sanctioned in the Memo may be made to the Muslim Pensioners/family pensioners immediately on receipt of this circular and other than Muslim Pensioners/Family pensioners, the payment in this regard may be made in between 3rdth October 2023 to 6th October 2023.
 - 5. In case of any doubt/difficulty, the matter may be referred to this office for clarification.
