PRESS NOTE

Subject: General Election to Legislative Assemblies of Jammu & Kashmir and Haryana, 2024 - Change of Date of Poll in Haryana and Counting of Votes in Jammu and Kashmir and Haryana- regarding.

The Election Commission of India had announced the schedule for General Election to the Legislative Assembly of Jammu and Kashmir and Haryana vide Press Note No.ECI/PN/128/2024 dated 16th August, 2024 wherein the date of poll for J&K (Phase-3) and Haryana was fixed on 1st October, 2024 (Tuesday), date of Counting on 04.10.2024(Friday) and date of completion of election process on 06.10.2024 (Sunday).


2. Subsequently, representations have been received from National Political Parties, State Political Party and All India Bishnoi Mahasabha regarding mass movement of people of Bishnoi community of Haryana to Rajasthan to participate in centuries old Asoj Amavasya festival celebration. It may deny voting rights to large number of people and may lead to reduce voters' participation in general election to legislative assembly of Haryana.

3. The Commission, having considered these representations, has decided to change the date of poll **only for Haryana** from 1st October, 2024 (Tuesday) to **5th October, 2024 (Saturday)**.

4. The revised schedule for the General Election to Legislative Assembly of Haryana and Jammu and Kashmir (Phase-3), 2024 is as follows:

Subject: General Elections to Legislative Assemblies of Haryana and UT of Jammu and Kashmir, 2024 – PAID HOLIDAY - regarding.

Madam/Sir,

I am directed to refer to the subject cited and to apprise that the Commission has announced the General Elections to Legislative Assemblies of Haryana and UT of Jammu and Kashmir, 2024 vide its Press Note No. ECI/PN/128/2024 dated 16.08.2024, available on the Commission's website under URL <https://www.eci.gov.in/issue-details-page/press-releases> The date of Poll for the said elections in UT of Jammu and Kashmir has been fixed on 18.09.2024(Wednesday), 25.09.2024(Wednesday) and 01.10.2024(Tuesday) in three phases and date of poll for Haryana is 01.10.2024(Tuesday).

2. In this regard, your attention is invited to Section 135B of the Representation of the People Act, 1951 which provides for the grant of paid holiday to the employees on the day of poll. Section 135B of Representation of the People Act, 1951 is reproduced below:

Section 135B: Grant of paid holiday to employees on the day of poll:

- a) Every person employed in any business, trade, industrial undertaking or any other establishment and entitled to vote at an

election to the House of the People or the Legislative Assembly of a State shall, on the day of poll, be granted a holiday.

- b) No deduction or abatement of the wages of any such person shall be made on account of a holiday having been granted in accordance with sub-section (1) and if such person is employed on the basis that she/he would not ordinarily receive wages for such a day, she/he shall nonetheless be paid for such day the wages she/he would have drawn had not a holiday been granted to her/him on that day.
 - c) If an employer contravenes the provisions of sub-section (1) or sub-section (2), then such employer shall be punishable with fine, which may extend to five hundred rupees.
 - d) This section shall not apply to any elector whose absence may cause danger or substantial loss in respect of the employment in which he is engaged.
3. The above provisions require that all the electors who are employee of establishments and shops including those which work on shift basis shall be granted a paid holiday on the day of poll in the Constituency where the General Elections to Legislative Assembly are to be held. Further, there may be cases where a person is ordinarily resident of the Constituency and registered as an elector, may be serving or employed in an industrial undertaking or an establishment located outside the Constituency having General poll. It is clarified that in such a situation, even those electors including casual workers working outside the constituency concerned would be entitled to the benefit of a paid holiday extended under the Section 135B (1) of the Representation of the People Act, 1951.
4. The daily wage/casual workers are also entitled for a holiday and wages on poll day as provided in Section 135B of the R.P. Act, 1951.
5. The Commission desires that suitable instructions shall be issued to all concerned and a copy thereof be endorsed to the Commission for its information and record.
