The Annual Audit Plan of GST for FY 2024-25 had been approved with selection of 13 units for audit (One Audit Commissionerate, One PAO, Two Tabaco Units, Four Divisions and Five Ranges). Out of 13 units, audit of 11 units have been completed till 3rd Quarter. Audit of Remaining two units (Lathikata Range and Dhenkanal Range) are proposed to be covered in the 4th Quarter.

Further in the Annual Audit Plan of Customs for FY 2024-25, four units were approved for selection audit (One Commissionerate and three Customs Division). Out of four units audit of three units have been completed till 3rd Quarter and the remaining unit (Customs Commissionerate BBSR) is proposed to be covered in the 4th Quarter.

Status of Audit Parties.

- 1. CRAP-10 is associated with the PA on 'Assessment, Levy and Collection of GST on Mines and Minerals' and the PA is expected to be completed by March 2025.
- 2. CRAP-09 is associated with PA on 'Project Import' and the PA is expected to be completed by the end of January 2025.
- 3. CRAP-07 and CRAP-08 are associated with SSCA on 'Works Contract /Construction Services under GST' and the SSCA is expected to be complected along with reply to the queries from Hqrs by the end of January 2025.
