CIRCULAR NO WM-I/16 DATE:- 04.10.2022

As per Hqrs. Office letter No. 421/13-Exam/Examination-I/2022 dated 27.09.2022, SAS/ IE/CPD-I, II & III Examination-2 of 2022 would be held from 15.12.2022 to 21.12.2022. Registration process for SAS/ IE/CPD-I, II & III Examination-2 of 2022 has commenced from 3rd October 2022. Applications are invited from eligible candidates for the following examinations.

The eligibility criteria for appearing in SAS/ IE/CPD-I, II & III Examination-2 of 2022 is mentioned below:

A. SAS Examination-Civil Accounts/Civil Audit stream

Completion of 2 years of continuous service in one or more posts of level 2 to 8 in this office and successful completion of probation period as on 1/9/2022 and the mandatory Pre-examination training.

B. Incentive Examination

Divisional Accounts Officer-Grade-I who have put in one year continuous service in the grade as on 01.09.2022 and all Sr DAOs who did not appear in this examination or could not clear the said examination while working as DAO-I are also eligible to appear /reappear in this examination.

C. <u>CPD-I</u>

All Sr. DAOs are eligible to appear in the CPD-I Examination -2 of 2022, DAO-I would be eligible to appear in the examination only after completion of four years of continuous service as on 01.09.2022.

D. CPD-II

All those candidates who have successfully completed 4 years of regular service as on 01.09.2022 after passing the CPD-I Examination are eligible for CPD-II Exam 2 of 2022.

Such of the eligible candidates who intend to appear in the SAS/IE/CPD-I, II & III Examination 2 of 2022 may submit their duly filled in applications in the prescribed proforma

(enclosed) and mail the same to <u>ag-ahmd-guj@nic.in</u> by 05.10.2022. Candidates should clearly mention the medium of examination i.e. Hindi or English in the application proforma. Candidates should clearly mention in the application form whether they intend to appear in Group-I, Group-II or both the group of Examination-2 of SAS Examination 2022. Candidates applying for IE and CPD-I/ or CPD-II/ CPD-III Examinations must submit separate application forms and should clearly mention the name of examination in the concerned application form.
