Subject: Inviting applications from displaced officers/officials of IA&AD offices in Manipur for the posts of Assistant Audit Officer, Assistant Supervisor, Senior Auditor and Auditor on deputation basis – regarding.

Applications are invited from displaced and eligible Assistant Accounts Officers/Assistant Audit Officers, Assistant Supervisors, Sr. Accountants/Sr. Auditors and Accountants/Auditors in IA&AD Offices of Manipur to fill up the existing vacancies of this office in the posts of Assistant Audit Officer, Assistant Supervisor, Senior Auditor and Auditor on deputation basis on the following terms and conditions:

1. The deputation will be initially for a period of one year, extendable thereafter annually subject to administrative convenience and the performance of the officer/official at work.
2. Officers/officials willing to apply for the deputation should not be aged more than 56 years as on the closing date of receipt of applications.
3. Selected officers/officials will be entitled to deputation allowance as applicable, in accordance with the relevant instructions issued by the DoPT, as amended from time to time. Further, the deputation will be regulated in terms of Headquarters Office Circular No. Staff (App)-1/14-2023 dated 27-01-2025.
4. The officers/officials may be repatriated to their parent office at any time as per administrative convenience.
5. In this regard, the respective offices are requested to recommend the names of eligible officers/officials who are willing and can be spared immediately in the event of their selection to the posts of Assistant Audit Officer, Assistant Supervisor, Senior Auditor and Auditor on deputation basis. The recommendations, accompanied by the filled-in bio-data (copy enclosed), disciplinary and vigilance clearance certificates, and attested copies of APARs for the last 5 years, may be forwarded to this office by 27-03-2026.
