GOVERNMENT ORDER NO. FD 19 SRP 2019 BENGALURU, DATED 4th NOVEMBER 2019

Government are pleased to enhance the rates of Dearness Allowance from the existing 54.25% to 60.25% of the basic pension/family pension with effect from 1st July 2019 to retired teachers who were drawing salary in 2006 Revised UGC/AICTE/ICAR scales of pay and who retired on or after 01-01-2016.

- For the purpose of this order, the term 'Basic Pension/Family Pension' means, the amount of pension determined as per the provisions of G.O. No. FD(Spl) 113 PEN 2. 2013 dated: 07-01-2013.
- The provisions of G.O. No.FD 14 SRP 2018 dated: 10-07-2018 shall continue to apply until further orders.
- The increase in Dearness Allowance admissible under this order is payable in cash until further orders.
- . The payment on account of Dearness Allowance involving fractions of 50 paise and above shall be rounded off to the next rupee and fractions less than 50 paise shall be ignored.
