# e-SANCTION and e-BUDGET

## e-SANCTION

- Sanction orders are generated online as a pre-activity of bill creation and tagged to the bills
- Sanction orders are approved by competent authority for limits and DSC signed
- General Delegation of Financial powers and Special Delegation of Financial powers wherever applicable are validated through the system
- Claims prepared with online sanction orders are validated for the values in sanction order against the classification, recipient category and financial limit

## e-BUDGET

All the Budget Control processes are operationalized in Khajane 2 across the entire financial hierarchy

### ❖ Processes related to Budget Releases

- Authorization to Incur Expenditure (AIE)
- Delegation of Financial Power for release of funds (GDFP)
- Fund Releases and Fund Redistribution

### ❖ Processes meant for Budget Modifications

- Re-appropriation
- Supplementary Estimates (SE)
- Additionality
- Contingency Fund
- Surrender of Fund / Savings / Errata

# e-RECEIPT and e-PAYMENT

## e-RECEIPT

- Receipts Module of Khajane-II captures and records all the receipt transactions of Government of Karnataka (Tax, Non-tax and TTRs) through multiple modes of Netbanking, Credit & Debit Cards, UPI, NEFT/RTGS etc.,

## e-PAYMENT

- Khajane is integrated with Electronic Payment Systems (EPS) for all government payments directly to the beneficiary bank accounts
- Various modes of payments enabled are DBT, Account based transactions, e-RUPI, In Kind, etc.

# e-HRMS and e-VOUCHER

## e-HRMS

- HRMS is a separate standalone application used for generation of Government employees as well as Grant in Aid employees salary bills
- Khajane 2 is integrated with HRMS and employee salary related claims are being fetched from HRMS

## e-VOUCHER

- Khajane 2 system developed e-Vouchers submission from the year 2022; however printed copies of e-vouchers being submitted to AG office
- Major step taken from June 1<sup>st</sup> 2025 wherein submission of printed copies of e-vouchers related to salary bills (around 7.5 lakhs bills annually) were completely eliminated
- Phased roll out is in progress to render e-Vouchers to AG digitally and completely eliminate submission of printed copies of other types of claims
- Digitized bills are transmitted with digital signature using 'server-to-server' communication to maintain data integrity and compliance to IT Act

# WORKS MANAGEMENT & GOODS PROCUREMENT

## WORKS MANAGEMENT

- Key modules available in e-Procurement system
  - ✓ Administrative approval of works
  - ✓ Tendering
  - ✓ Contract Management
- Khajane-2 and e-Procurement are integrated to facilitate digitised bill processing for works bill
- On pilot basis, digitised voucher is being shared with AG with the following system generated documents:
  - ✓ e-Measurement Book
  - ✓ Contract certificate
  - ✓ Sanction Order
  - ✓ Digitally signed voucher
- Submission of printed copies of bills and tampering of documents related to works gets eliminated

## GOODS PROCUREMENT

- Workflow is being developed to facilitate end-to-end digitised processing of bills relate to goods procurement that includes online invoice generation
- Tendered Procurement (> INR 5 lakhs worth procurement)
  - **e-Procurement:** Workflow developed for admin approval, tendering, e-signed invoice submission by vendors; Khajane-2 is integrated with this system
  - **GEM:** Khajane 2 is being integrated with GeM to get the procurement invoice and draft bill
- Other Procurement (< INR 5 lakhs worth procurement)
  - **Vendor Management System:** Khajane-2 is developing a module that enables generation of e-signed purchase orders and invoices
