Subject: Annual General Transfers-2024-Option for Transfer.

As per Headquarters office guidelines, the DA Cadre officials at enlisted in Annexure-I are due for transfer this year. All these officials may, therefore, furnish option for THREE different stations of their choice of posting in the order of preference.

While submitting the options, following factors may be kept in mind:

1. Transfer and Posting of DA Cadre officials will be done the basis of the guidelines/circulars/clarifications issued by the Headquarters office time to time.
2. Stations opted by the DA Cadre officials will be considered subject to availability of vacancy, relevant guidelines and administrative exigencies.
3. It is likely that the appropriate division may not be available to accommodate in opted stations. In that case, a nearby station of opted stations will be considered for the transfers and posting.
4. The option received by fax, email or in person and received after due date will not be considered and posting will be decided as per the vacancy position.
5. Transfer and posting of officials will be done in appropriately graded divisions based on factors like average annual expenditure, nature of work in the division, territorial jurisdiction of the division, performance of the officer, geographical distribution of officials, administrative exigencies, etc.
6. In view of ongoing exercise of determination of inter-se seniority, the Headquarters' office, in order to avoid any disturbance in / of academic session, has directed that the Annual General Transfers-2024 may be conducted on the basis of pre-revised inter-se seniority of DA Cadre, as on 01/03/2023.

The option should be sent by Speed Post to this office in sealed envelope addressed to "Shri Bhushan B. Bhirud, Sr. Deputy Accountant General (Works Accounts)" and super scribed as "CONFIDENTIAL – OPTION FOR POSTING" on the envelope on as to reach him by 4.00 pm on 17/05/2024.

A list of vacant divisions as well as divisions likely to fall vacant showing its grade which are being filled during the Annual General Transfers 2024 is hosted on the office website to help you in exercising the option to choose the convenient station.
