“Though the panel has to be drawn up by the Central Government Employees Welfare Coordination Committee keeping in view the requirements of the Central Government Employees stationed at a particular place and their geographical distribution, the actual nomination of Authorised Medical Attendants should be done by the individual Heads of Department to meet their requirement. Hence, all Doctors included in the panel would not be nominated for particular office/Departments unless considered very essential.
