- 5. In pursuance of Para- 6 (B) (Note-II) of Headquarters' instructions issued vide letter No. 125-Staff Entt (Rules)/AR/02-2021 dated 05-08-2022, age relaxation has been granted by the Head of the Department.
- 6. The Committee has taken into consideration the following documents before considering the application for compassionate appointment and arriving at a conclusion.

a) GoI OM vide F. No. 14014/1/2022-Estt. (D) dated 02-08-2022.

- b) Headquarters' Circular No. 14 (No. 52-Staff Entt (Rules)/AR/02-2021) dated 20-04-2022.
- c) Headquarters' letter No. 130-Staff Entt (Rules)/AR/02-2021 dated 24-08-2022.
- d) Financial enquiry / verification report of the applicant.
- 7. The Committee has carefully considered the application for compassionate appointment, and other associated records and unanimously recommends the following:

"That the object of the scheme is to grant appointment on compassionate grounds to a dependent family member of a Government servant dying in harness thereby leaving his family in penury and without any means of livelihood, to relieve family of the government servant concerned from financial destitution and help it to get over the emergency. The deceased government servant in this case was holding the post of Assistant Audit Officer and was at the time of death drawing a basic pay of Rs. 75,600/-. Consequent upon his death the family of the deceased would receive a sum of Rs. 5,99,836/- as terminal benefits after adjusting the outstanding HBA and interest thereon. Furthermore, the applicant has also mentioned that there is a Personal Loan lying outstanding amounting to ₹8,41,047.66/- (upto January 2025) which is being recovered @ ₹18,906/- per month. The spouse will receive a family pension of Rs. 37,800/- (at enhanced rate from 14-11-2024 to 13-11-2034) and Rs. 22,600/- (at ordinary rates). The family is left with immovable property (plot and ready built house) having estimated valuation of Rs. 33,00,000/-. Besides, as informed, the education qualification of the applicant Joyce Lalhnemzo is H.S (+2).

In terms of Annexure V (ii) of Headquarters circular No. 14 dated 20-04-

2022 total marks obtained by the applicant is 90 (enclosed Annexure II).

Hence, after careful consideration of all the facts of the applicant and the Committee's report it is reasonably found that the family of the deceased is found convincingly to be in economic distress and requires immediate financial assistance and therefore recommends that the case is fit for appointment to the post of MTS in office of the Accountant General (Audit), Tripura, Agartala on compassionate grounds."
