One post of Welfare Assistant in the Level 8 of Pay Matrix ₹ 47600-151100 is to be filled up on deputation basis from eligible staff in all IA&AD Offices.

The conditions of eligibility are as under:-

Officers of the Central Government-

- Holding analogous posts on regular basis in the present cadre or department or;
- With combined regular service of 3 years in the grade of Senior Accountant / Senior Auditor and Assistant Supervisor (Accounts) / Assistant Supervisor (Audit) in the Pay matrix Level-7 / Level-6 or equivalent Pay Level in the parent cadre of the Department;
- Possessing three (03) years experience in the field of Welfare or Community activities, House Keeping, Sports and Cultural activities, Personnel Administration including settlement of personal claims, etc;
- The maximum age limit for appointment on deputation shall be not exceeding 56 years on the closing date of receipt of applications.
- The deputation (duty) allowance will be payable at the rate of 5% of the basic pay subject to maximum of ₹ 4,500/- per month in the case of deputation within the same station.
- In other cases, the deputation (duty) allowance will be payable at the rate of 10% of the basic pay subject to maximum of ₹ 9,000/- per month.

Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some organization or Department of the Central Government shall ordinarily not exceed three (03) years.

The eligible and willing officials may apply in enclosed proforma through proper channel so as to reach Establishment Officer on or before 30th April, 2024.

Applications received after the prescribed date will not be entertained.
