OFFICE ORDERNO. 194

With reference to the New Sports Policy for promoting sports in IA&AD, Competent authority has directed the following:

- 1. The players of CAG's Team as listed in Annexure-I are relieved of their duties from **02:00 pm onwards** daily throughout the year for practice and to maintain fitness/form for the tournament and are to be under supervision/monitoring of a Sr. player mentioned against each player.
- 2. The players who represent AG's Team during IA&AD Zonal/Inter-zonal tournaments or the players who participate in State/National level tournaments as listed in Annexure-II are allowed time relaxation from **03:00 pm onwards** daily throughout the year for practice and maintain fitness/form for the tournament under supervision/monitoring of the Sr. player mentioned against each player.
- 3. The sports quota recruited players, **prior to 2011** whose names are not in the present list, but who may represent their respective AG Offices, State, or participate in the National tournaments, may be allowed time relaxation from 3 pm onwards at least 30 days prior to commencement of tournaments.
- 4. The concerned players availing time relaxation (2 pm/3 pm onwards daily) will intimate in writing to their respective sections & Welfare section regarding the address of their practice/fitness venue. In case of any change of their place of practice, the same should be intimated by them immediately to welfare section.
- 5. The players nominated for supervision of players of various sports discipline (at annexure I&II) should submit a monthly report to the Sr.AO/Welfare Section regarding the attendance and fitness of the players.
- 6. The players recruited under sports quota can play from any State (AP or Telangana).

- 7. The players mentioned in the Annexure-I (C&AG Team players) have to take NOC/permission from Hqrs to participate in any league/tournament individual capacity. Letters received from any association/federation should be referred to Hqr's office for NOC/permission. The letter or NOC should reach Hqrs at least 10 days before commencement of the tournament, otherwise NOC/permission shall not be granted. Hence, all the CAG players are directed to submit letters received from Association/Federation well in advance in **Welfare Section** so that the same will be forwarded to Hqrs for taking NOC/permission.
- 8. If any player is found to be absent in practice without any intimation/reason at regular intervals, the same will be intimated to Hqrs' office for exclusion of name of the concerned player from the list followed by cancellation of practice order.

The above orders remain valid till further orders issued by Hqrs. Office or this Office.
