**Sub: - Information on State Government Pensioners drawing Pension from outside the State of Odisha-reg.**

Sir,

The Finance Department in Government of Odisha, desires that the practice of Special Seal Authority has to be reviewed and if feasible to be dispensed with as the existing pension disbursement system of IFMS, revision of pension, increase in the TI rate and monthly pension is directly being credited into the Bank account of the pensioner without the pensioner appearing before the Treasury Officer on monthly basis. The pension and other pensionary benefits can also be disbursed to the account of the pensioner located anywhere in India. Hence, need for movement/transfer of pension records from one state to another does not look feasible. In this connection, Director of Treasuries and Inspection, Odisha vide their letter No. Pen-II-63/19-No.12183/DTI dt. 27.09. 2019 has requested this office to collect the following information from different AG Offices in respect of the Odisha Government pensioners in whose favor Special Seal Authorities have been issued for preparation of a list/ master data for proceeding further in the matter.

Hence, you are therefore requested to kindly provide the following information for onward transmission to the Director of Treasuries and Inspection, Odisha, Bhubaneswar for further necessary action, only on receipt of approval from Hqrs. sought for regarding this.
