The undersigned is directed to refer to this department's O.M. of even number dated 12th May 2022 and to state that the Governor of Nagaland is pleased to enhance the Dearness Relief to Pensioners and Family Pensioners of the Government of Nagaland from the existing rate of 34% to 38% w.e.f 01.07.2022

2. Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
3. The Principal Accountant General (A&E), Nagaland, is requested to circulate this O.M. to the Accountant General of all States so that Pensioners of the Government of Nagaland drawing pensions under their jurisdiction may be authorized for payment of this relief at the earliest.
