This is to also inform all Departments once again that since this office relies on PIMS data for confirmation of pension cases, a preliminary check on all pension cases will be initiated at the Reception Cell before officially receiving the Pension cases for settlement.The basic information to be checked are as follows:</p> <ol style="list-style-type: none"> <li>1. Name should match in both PIMS and service book</li> <li>2. Date of birth should match in both PIMS and service book</li> <li>3. Date of entry into Government service should match in both PIMS and service book</li> <li>4. Date of retirement should match in both PIMS and service book</li> <li>5. The ID mark of a government servant should match in descriptive roll and service book .</li> <li>6. Name and date of birth as recorded in the Aadhaar card may be furnished in both service book and list of family membrs.</li> <li>7.Th Head of the Department will be the pension sanctioning authority in case of Non-gazetted officials and the Secretary of the concerned department will be the pension sanctioning authority for gazetted officers .</li> <li>8.Photocopy of service book for process of pension will not be accepted .All Departments are requested to submit original service book for process of pension.</li> </ol> <p>The preliminary check on Pension papers is being done to avoid sending of objections/observations at a later stage.
