I am to refer to the G.O and letter cited on the subject mentioned above and to communicate hereunder the amount of premium to be deducted for the third year 2020-2021 (5<sup>th</sup> and 6<sup>th</sup> instalment) from the pensioners/family pensioners who have opted and enrolled under the "Contributory Medical Benefit Scheme" for the retired pensioners/family pensioners.

2. Premium calculated for the third year as per para 3 of the G.O.Ms.No.12 and serial No.7 of the terms and conditions attached to the said G.O. Amount of premium Rs.4160/- + applicable G.S.T i.e 18% = Rs.750/- (4160 + 750 = 4910/-) for the third year. The 5<sup>th</sup> and 6<sup>th</sup> instalment = 2455/- per instalment.



3. The 5<sup>th</sup> instalment of Rs.2455/- has to be recovered from the pension payable for the month of April 2020 and deposit the same immediately in to the relevant Head of Account of the Director of Health & Family Welfare Services (Account No.37673953679) in the State Bank of India, Main Branch, Puducherry which has already been communicated vide letter third cited.
4. The 6<sup>th</sup> instalment of Rs.2455/- has to be recovered from the pension for the month of October 2020 from all the enrolled pensioners/family pensioners without waiting for any communication and deposit the same in the account mentioned above para.
5. The new applications obtained/received from the eligible pensioners/family pensioners for new enrolment into the scheme, duly authenticated may be forwarded to this Directorate along with covering letter indicating the name and PPO of the applicant for onward transmission to the Directorate of Health and Family Welfare Services, Puducherry.
6. The applicable premium as per G.O.Ms.No.12 may be recovered from the new applicant and remitted then and there into the Directorate of Health and Family Welfare Services, Puducherry account as stated in the para 3 above without waiting for further communication. Thereafter, the list of pensioners with PPO No from whom premium has been deducted may be sent to the Directorate of Health and Family Welfare Services, Puducherry marking a copy to this office.
